The Council considers that the circumstances exist to warrant permitting the proposed residential development as an exception to Policies 5 and 12 of the Joint Lancashire Structure Plan as the site is located within the boundary of the emerging Bacup, Stacksteads & Britannia Area Action Plan, and the proposal provides for the sympathetic conversion of a traditional rural building that would otherwise fall into disrepair.
