3. RISK ASSESSMENT IMPLICATIONS

3.1 There are no specific risk issues for members to consider arising from this report.

4. BACKGROUND AND OPTIONS

Tariff 1 Flag increase

- 4.1 A written request was received from the Rossendale Taxi Association requesting that the Hackney Carriage Flag 1 tariff be increased to £2.50. A copy of this request is at Appendix 1.
- 4.2 At the Taxi Liaison Group on 4th September 2007 it was agreed that this request would be taken to the Licensing Committee for determination. An extract from the minutes of the meeting is included at <u>Appendix 3</u>.
- 4.3 This request relates to the Flag only and not the running cost per mile after the 1st mile.
- 4.4 No request has been made to revise tariff 2 however, for information, national comparative data on tariff 2 at is included at <u>Appendix 8</u>.
- 4.5 The current table of fares for hackney Carriages distance and times is included at Appendix 4.
- 4.5 Comparative National Data from the National League Tables compiled by Private Hire & Taxi Monthly magazine for September 2007 is as follows:-

Revision of soiling fee

- 4.8 A request was received from the Independent Taxi Driver Association requesting that the fee for soiling a Hackney Carriage be increased from £20.00 to £40.00 (Appendix 2).
- 4.9 The purpose of the soiling fee is to cover the cost of valet and loss of earnings should a passenger soil a hackney carriage during the hiring of the said vehicle, which renders the vehicle unsuitable for public hire. It is important that any bodily fluids are removed properly and thoroughly before any further hiring of the vehicle.
- 4.10 The cost of a professional valet is approximately £35.00 and the current set soiling fee does not cover this.

- 4.11 This item was discussed at the Taxi Liaison Group on 4th September 2007 and the relevant extract from the minutes is attached at Appendix 3.
 - 4.12 At an earlier meeting of the Taxi Liaison Group it was established that collection of this fee is a civil matter, with this in mind the taxi trade were asked to suggest a figure that could be reasonably charged, which would not render collection difficult.
 - 4.13 At the Taxi Liaison Group on 4th September 2007, it was agreed that a figure of £50.00 was reasonable, which takes into account the cost of a professional valet and would include approximately £15.00 for loss of earnings.
 - 4.14 It is noted that £15.00 does not fully cover loss of earnings, however, to set the figure too high creates a risk of rendering collection difficult.

<u>Further review of the current table of fares for hackney carriages – distance and</u> waiting time with regard to the extra charges

- 4.15 The Committee are requested to determine further updates with regard to the extra charges as follows:-
- 4.16 Under Extra Charges: For hiring between midnight and 6:00am and on Sundays and Statutory Holidays (except Christmas Eve, Christmas Day, New Year's Eve and New Year's Day): + 50% of mileage charge (Tariff 2)
- 4.17 The Committee are requested to determine whether it is appropriate to include 'and on Sundays'. Applying extra charges on Sundays is not common practice nationally and on speaking to the Taxi Trade within Rossendale they do not appear to increase the fees on Sundays
- 4.18 The Committee is further requested to review and determine the time stated for extra charges to: For hiring between 2.00am and 6:00am.
- 4.19 It is believed that promoting lower fares after midnight will reduce the risk of people leaving public houses and night clubs (for example) alone and by foot and encourage the public to use hackney carriages to get home safely.
- 4.20 On consultation with the Taxi Trade it is noted that few drivers apply tariff 2 after midnight and application of the tariff is left to the discretion of individual drivers.
- 4.21 <u>Appendix 7</u> has been supplied for information to show how these changes would affect the current table of fares.
- 5. COMMENTS OF THE HEAD OF FINANCIAL SERVICES
- 5.1 There are no direct financial implications.
- 6. COMMENTS OF THE EXECUTIVE DIRECTOR OF REGULATORY SERVICES

7. COMMENTS OF THE HEAD OF PEOPLE AND ORGANISATIONAL DEVELOPMENT

7.1 There are no direct Human Resource implications.

8. CONCLUSION

- 8.1 To increase the flag tariff on the taximeter to £2.50 would benefit the employers of Hackney Carriage drivers who have to consider the overall running costs of their business.
- 8.2 An increase to £2.50 for the flag tariff on the taximeter is considered reasonable when compared to hackney carriage fares nationally.
- 8.3 Increasing the flag tariff on the taximeter to £2.50 would impact on the 'employed' Hackney Carriage driver's who are often paid £2.50 by the hirer and use the 20p tip to top up their earnings
- 8.4 To increase the soiling fee is a reasonable request and would benefit both the Hackney Carriage driver's and their employers
- 8.5 A review of the extra charges on Sundays and the current times tariff 2 comes into force would benefit the Rossendale people, promote Rossendale as a place to live and visit and be in the interest of public safety
- 8.6 The review of the extra charges would have a minimal effect on the taxi trade as very few drivers currently apply tariff 2 after midnight and on Sundays

9. RECOMMENDATION

- 9.1 That the Committee considers the Taxi Trade's request to increase the tariff 1 flag to £2.50 for the first mile.
- 9.2 That the soiling fee is increased to £50.00.
- 9.3 That the extra charges within the 'Table of Fare' are reviewed.
- 9.4 That any changes be implemented by 26th November 2007.

To the licensing unit of Rossendale Council:

Rossendale Taxi Association would like for the following items of our agenda to be taken into account for the next meeting.

1. Could we please have a fixed monthly price for the license of £16 if the vehicle does not have 12 months to run?

During a recent thought in the licensing offices a change was made to the price of a vehicle license. Previously if the vehicle was being licensed but only had 6 months left to carry out on its age, a verbal understanding with the council was the charge would be at the rate of £16 a month not the full £200 12 month charge. This was working very well and the Trade had no complaints until the licensing Manager decided to make alterations so we were charged £200 for 3/6/9/or 12 months.

2. We would like to ask the age of a minibus please be granted at 7 years 365 days till the current 9 years 365 days.

At the moment the age of a minibus to be granted license is the same as a car which the committee helpfully granted a few years back, it has to be licensed before its 6th year from first registration.

As a car run's till its 8th year anniversary, which is a period of 2 years, a Minibus can run till its 10th which is a period of 4 years.

Due to recent changes in the licensing rules, minibus's have to be manufactured as so and NOT a converted van. While we take into account this change was made for safety reasons, it has made the price of a minibus to the trade more expensive. Our plan would still see the same age of bus on Rossendale Roads as they still run till there 10th anniversary from first registration with the same 6 monthly rigorous MOT test's but we would be able to bring them on at 8 years of age and run them for there last 2 years, same as the car.

3. We would like the minimum fare to be revised to £2.50 for the first mile.

Unfortunately due to constant rising charges to the trade with fuel, insurance, upkeep of vehicles etc. the trade would like to ask the minimum charge have a

I am also formerly requesting at this time that the soiling charge currently set at £20 be increased to £40 as we feel that this is a much more reasonable figure when considering the costs and the loss of earnings incurred for driver and vehicle alike by such behaviour.

Having checked the league tables in the taxi and private hire monthly for this charge in other boroughs, the soiling charge is not listed, having said this after discussions with members, we are certain that £20 is too low.

We do however take into consideration your concerns in relation to the difficulty in the collection of this increased amount, but we have concluded that this would act more as a deterrent for the public than the current amount.

We also feel that it will prove to be no more difficult to collect £40 than it is already to collect £20 but we do feel that the increase would create a more reasonable amount to request from passengers.

7. Fares Increase request update

JB advised that they would like the initial charge of £2.30 increased to £2.50. The association advised that they do not wish for the running costs to be looked at.

TB enquired as to the number of drivers approached about the increase who are in favour of it.

JB advised that 119 people had been asked and 119 people were in favour of the increase.

TB advised the group that 12 drivers had provided information that they do not support the fares increase as clients would normally pay £2.50 anyway and the increase would then result in the loss of the 20p tip to the driver.

JB advised that the extra 20p is required for running costs.

8. Soiling Charge update

DL presented his request to have the soiling charge increased to £40. A discussion on this took place and comments from previous meetings were re-iterated. TB suggested that a realistic recoverable amount would be £50.

JB and RB advised that they would be happy with the charge of £50. JB and RB also stated that soiling was a rare occurrence. RB advised that it amounted to approximately once or twice a year per car.
