    - By working with businesses and offering support, advice and information we are helping businesses to comply with legislation and thereby strengthen their businesses.

    - o The whole purpose of food law enforcement is to ensure that food is produced, manufactured, handled and transported so that it is safe and poses no risk to consumers. In addition, our work with the Food Forum is designed to impact on issues such as obesity and healthy eating which are also important factors in the way food impacts on people's health.

## 3. RISK ASSESSMENT IMPLICATIONS

### 4. BACKGROUND AND OPTIONS

- 4.1 The Food Standards Agency was established to have a key role in overseeing local authority enforcement activities. They have been proactive in setting and monitoring standards and auditing local authorities' enforcement activities in order to ensure that this activity is effective and undertaken on a consistent basis. Powers to enable the Agency to monitor and audit local authorities are contained in the Food Standards Act 1999.
- 4.2 Service Plans are seen to be an important part of the process to ensure national priorities and standards are addressed and delivered locally. They have produced Guidance and Codes of Practice to aid local authorities in their enforcement function. They have also produced a template for the Service Plan to enable Authorities to demonstrate, in a consistent format, how the Authority is providing a balanced service in relation to its constituent functions and how it performs.
- 4.3 The Framework agreement was signed on behalf of Local Authorities in 2001 by the Local Authorities Co-ordinating Body on Food and Trading Standards (now known as LACORS) and came into force on 1<sup>st</sup> April 2001. A requirement of the agreement is that Food Service Plans, in the required format, be submitted to the relevant member forum for approval to ensure local transparency and accountability.
- 4.4 The Framework Agreement also requires each Local Authority to maintain and implement a documented sampling policy and programme in accordance with any centrally issued or relevant guidance. The Policy should be a public document although the Sampling Programme, or when and where sampling will be undertaken, is not public information as it may jeopardize the effectiveness of the exercise.
- 4.5 The Food Law Enforcement Service Plan 2007/8 and Sampling Policy are attached to this report.
