- 4.5 Inclusion of a Borough Profile and Key Challenges & Opportunities section.
- 4.6 The achievements section has been reduced based on our approach that the Corporate Plan is the Council's forward looking document. In line with this the achievements incorporate into this Corporate Plan are only a selection of the Council's achievements during 2008-09. A more comprehensive review of its achievements will be incorporated into the Annual Report.
- 4.7 Inclusion of Priority Councillor Leads.
- 4.8 Replacement of the old BVPI performance data with the new Local and National Performance Indicators.
- 4.9 Inclusion of a Glossary of Terms.
