Annex 1 - Mandatory Conditions

No supply of alcohol may be made under the premises licence at a time when there is no designated premises supervisor in respect of the premises licence or at a time when the designated premises supervisor does not hold a personal licence or their licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Conditions imposed by virtue of paragraph 6(8) Schedule 8 Licensing Act 2003

Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means:

Between 1100 hours and 0100 hours Monday to Thursday.

Between 1100 hours and 0200 hours Friday and Saturday.

Between 1100 hours and 0100 hours Sunday only.

On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day.

The above restrictions do not prohibit:

During the first thirty minutes after the abvoe hours the consumption of the alchol on the premises;

During the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;

During the first thirt minutes after the above hours the comsumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;

No alcohol sall be supplied otherwise than to:

- ?? a member of the New Hall Social Club who has been a member for at least 2 days or whose nomination or application for membership was made at least 2 days before his admission
- ?? A guest of such a member bona fide entertained by him at his own expense
- ?? a person whose admission to the club premises is provided for by the rules of the club

There shall be rules of the club for the election of members and a copy of such rules and any other rules shall be deposited with the Licensing Authority. Notice of any alteration in any of the rules shall be given to the Licensing Authority within 14 days.

A list of the names and addresses of all members of the club shall be kept ont he premises and produced on demand for inspection by a Constable or an authorised officer of the Licensing Authority.

No alteration shall be made in the rules for the admission of persons other than members referred to in the conditions above without the consent of the Licensing Authority.

The minimum annual membership fee shall be £1.

The maximum occupancy of the premise shall be agreed with the Fire Service.
