past licensing flours. These disturbances also frequently occur as shouting and
swearing until early hours in the morning from people in attendance of The Groop
Squirrel.
Frequent taxi horns after 23:00 to get the attention of clients within the premises and
the large amount of traffic noise from numerous engines of taxi's awaiting fares on
busy nights.

especially in hot weather and cannot leave windows open in own homes.

Since the opening of the Green Squirrel in 2011 our family life has been seriously disrupted.

There is regular loud music that can be heard above our TV and in every room in our house. This has prevented us from feeling 'comfortable' in our own home. We understand that the pub has been set up as a business but this has been done without any consideration to the residents in the vicinity of the premises.

Glen and Ann, the previous owners of The Crown, placed an emphasis on the control of disturbances and disorder both in and outside the pub. This is something that we do not feel that current owners show any concern for.

The Green Squirrel's music is repeatedly at an unacceptable level, and is frequently played later than the legal licensing hours. In such a high residential area we do not feel that it is appropriate for a pub to have such late hours and a license to allow such loud music.

My wife and I are frequently unable to go to bed when we wish as we are unable to sleep due to the loud music and disturbances outside the pub. For a working couple who are studying and have a young son this often results in us getting disturbed patterns of minimal sleep at a weekend, and affects our quality of life in our own home.

As we are studying, we often do not watch television in the evenings, but find that we are unable to work due to the noise from the pub, which can be heard above our TV, and is unbearable when we do not have the TV on.

Our Son's bedroom is at the back of the house and in warm weather he is often unable to sleep at weekends because he can hear the music and we are unable to open his window as this will accentuate the problem. It is not acceptable to be unable to open windows in our home, as this is often the case due to the noise from the pub.

Once the music has finished the problem continues with people shouting and swearing when entering or leaving the premises or people stood outside, either at the front or on the open land to the side, doing the same. This can go on until late as they have a license until 2am, creating a further issue. There is increased traffic noise into the early hours of the morning due to taxis forming queues outside the pub and several cars coming and going.

I would like it made clear that I do not have a problem with there being a public house across from my home but this should not come at the expense of neighbours. The continuing loud music and the disturbances from patrons that seem to have a 'blind eye' turned to them by the licensee has created an 'air of tension' in what was once quiet and friendly neighbourhood.

I would finally like to note that the disturbances from the pub must also be affecting the buying and letting of property in the close vacinity.

I live about 60-70 netres from the Green Squirel Public House. I have lived peacefully in this area for the poor Eyears but since The Green Squired opened l'ast summer there have been times when noise and behaviour of this premises customers have consect me problems. I had been overtocking these issues as I believed they round subside after the publication of terring text they have not. I personally have 3 issues that I would like adelessing 1. The Green Squirrel plen has misic playing at the weekend. The pub without are often open this means that the noise is not contained iside the predises and I can hear it. The much has a occasion been played post midnight which keeps we another. The mist ion he played so loud I can hear it word for word. As surver is approusing I would like to open my hecken window but an Rhitant because of the roise that eminates from the pub which like lost summer, effect my ability to sleep. Both me and my partner work nows which involve early starts before back. The playing of motic so loud at such a late how is macceptable and means note me and my partner have only managed 45 hours sleep which does effectively work. This cause me problems 18+ summer. Heckmay 2. There is a decrat the side of the pub which customers use who sneke. If my bedoon window is open I can usually hear their develocations word for word, along with their use of four and abasive language, which for some people would cause offene. 3. I am tied of fiching bottles and glosses on my well, pushed in the bushes at the frank of my house or traken with glass scattered along the powerfest in the imediate vicinty of my home. Since the Green Squired opened the appedrance of this broken glass has caused me problems. I have a day, which reeds weathing. Luckily up to now I have ranaged to keep his safe so he does not out his paws causing him pain and vets bills on my part. I understand that the owners of the Green Sommed was to provide extertaining for their customers and make the pub a serccess, but some consideration for the needs of it's reighbours would be appreciated.

Whilst we appreciate the entrepreneurial spirit behind the opening of the Green Squirrel public house, the "spirits level" has created an increasing number of problems for local residents. Previously we lived in a relatively quiet residential area – albeit on a main road - since the opening of this particular tavern, the following disruptions have increased – noise levels, keeping residents awake at night – specifically emanating from this hostelries "jolly customers" enjoying a cigarette and a natter alfresco in the evening air accompanied by wafts of booming bass end music coming from the interior, to the opposite end of the scale i.e. those inebriated revelers who decide to settle their boisterous disputes fisticuffs style on the municipal pavement. Combined with the setting up of an impromptu "Taxi Rank" along the front with all their toeings and frownings have made the noise level rate even worse, let alone the issue of parking 'which is already at a premium' – now a total impossibility - thus residents having to seek alternative places in streets further away to park their vehicles in, with no doubt annoying those residents in turn.

I like most of my neighbours enjoy a night out every now and then, however it is rather a different matter when you have it regularly inflicted upon you . You get the picture. It all boils down to being either a 'good' or 'inconsiderate' neighbour, we all have to co-exist, in order to do this there has to be defined boundaries of adherence and consideration.

We would really appreciate any assistance from you as a Council Authority to resolve this delicate situation.
