1. PURPOSE OF THE REPORT

1.1 This report presents the Councils second Local Development Scheme (LDS) prepared for submission to the Government Office for the North West (GONW)

2. RECOMMENDATIONS

- 2.1 That the Cabinet recommends that Full Council:
 - 1. Approves the Local Development Scheme (LDS)
 - 2. Delegates authority to the Leader of the Council and the Acting Chief Executive to ensure the submission of the Local Development Scheme (LDS) to Government Office North West by 28th March 2005.

3. REPORT AND REASONS FOR RECOMMENDATIONS AND TIMETABLE FOR IMPLEMENTATION

- 3.1 The LDS in accordance with Planning Policy Statement 12 (PPS) sets out the programme for the preparation for the Local Development Framework (LDF). The LDS provides an update to the first LDS prepared by the Forward Planning Team that provided an initial 3 year programme for preparation of Local Development Documents (LDD). The documents identified in the first LDS included:
 - Statement of Community Involvement (SCI)
 - Core Strategy

- Rawtenstall Town Centre Area Action Plan (AAP)
- Bacup, Stacksteads and Britannia Area Action Plan (AAP)
- Allocations Development Plan Document (DPD)
- Proposals Map
- Development Control Policy Development Plan Document (DPD)
- 3.2 The submission of the revised LDS is based on the implementation of the first LDS during the first year of the programme. The details of progress of the first year can be viewed in section 2 of the Annual Monitoring Report (AMR) that was submitted to GONW on the 30th December 2005.
- 3.3 The revised LDS will provide the programme and stages of preparation and consultation for LDDs identified in the first LDS and additional documents that will be required to provide Rossendale Borough Council's planning policy. The additional documents will for Rossendale Supplementary Planning Documents (SPDs) that will supplement the Core Strategy and Area Action Plans (AAP) currently underway. The SPDs identified in the second LDS include:

- 3.4 The Cabinet should note that prior to submission to the GONW, milestones and text in the LDS may be subject to change following advice from GONW and the Planning Inspectorate (PINs)
- 3.5 The preparation and submission of the LDS will be in accordance with the regulatory requirements set out in Part 3, Regulation 6 12 of the Town and Country Planning Act (Local Development) (England) Regulation 2004.

- 4.2.1 GONW and the Planning Inspectorate (PINs) are responsible for approving the LDS in accordance with Regulation 11(2) of the Town and Country Planning (Local Development) (England) Regulations 2004, whereby the First Secretary of State is satisfied with the contents of the Council's LDS and does not intend to issue a direction under Section 15(4) of the Planning and Compulsory Purchase Act 2004.
