#### 1. PURPOSE OF THE REPORT

1.1 To advise members of the current guidelines relating to the relevance of convictions in respect of applications for Hackney Carriage and Private Hire Driver's Licences.

1.2 The Committee are requested to approve the current guidelines without any further amendment.

# 2. RECOMMENDATIONS

2.1 It is recommended that the current guidelines be approved.

# 3. REPORT AND REASONS FOR RECOMMENDATIONS AND TIMETABLE FOR IMPLEMENTATION

- 3.1 The Local Government (Miscellaneous Provisions) Act 1976 makes a requirement that no hackney carriage or private hire drivers licence shall be granted unless the applicant is "a fit and proper person" to hold such a licence.
- 3.2 An element of determining whether an applicant is "a fit and proper person" is the results of a Criminal Records Bureau (CRB) check.
- 3.3 On this basis, the Committee last approved the guidelines relating to the relevance of convictions on 11<sup>th</sup> November 2003 as appended at Appendix A.
- 3.4 It is therefore necessary for the committee to demonstrate that these guidelines have been looked at and reviewed where necessary since their adoption in 2003.

- 3.5 It is recommended that these guidelines are still current and do not require any amendments and the committee are therefore requested to resolve to retain the guidelines in their current form.
- 3.6 Members should consider that the Hackney Carriage and Private Hire system is an important part of the public transport infrastructure of the Country and the purpose of a licensing regime is to ensure that the service to the public is accessible and safe, and seen to be so. Hackney Carriage and Private Hire drivers are persons of trust and maintains contact with the public.
- 3.8 In any case, since March 2002 all convictions, irrespective of age, remain 'live' for the purposes of a Hackney Carriage or Private Hire Vehicle drivers licence, these occupations being added to the exemptions list from that time (Rehabilitation of Offenders Act 1974) (Exemptions) Order 1975.
