### 1. REASON FOR REFERRAL

1.1 To advise members of an application for the transfer of a premises licence under Section 42 of the Licensing Act 2003.

### 2. RECOMMENDATION

2.1 It is recommended that members determine the application in accordance with the provisions of the Licensing Act 2003.

### 3. LICENSING OBJECTIVES

- 3.1 Members are reminded of the Licensing objectives as follows:
  - The prevention of crime and disorder;
  - Public Safety;
  - The prevention of public nuisance; and
  - The protection of children from harm

### 4. THE LICENCE

- 4.1 The premises is an off licence and has held a premises licence since 2<sup>nd</sup> September 2005. This licence would have remained dormant until the second appointed day (24<sup>th</sup> November 2005) when the provisions of the Licensing Act 2003 came into effect. This licence is appended at <u>Appendix A</u>.
- 4.2 There have been various transfers and designated premises supervisor (DPS) applications since that time.
- 4.3 On 13<sup>th</sup> July 2010 the premises licence was transferred to Mr Arulthas Arokkiyanathar THEVASAKAYAM who is the current premises licence holder.

### 5. THE APPLICATION

5.1 On 3<sup>rd</sup> November 2023, Mr Gulraiz SHARIF applied for the transfer of the premises licence. That application is appended at **Appendix B**.

- 5.2 At the same time, an application for the variation of DPS was submitted by Mr SHARIF. The applicant was identified as Mr THEVASAKAYAM. The application requested that it have immediate effect. This means that the premises licence has effect during the application period as if it were varied in the manner set out in the application.
- 5.3 At the same time, an application for the grant of a personal licence for Mr SHARIF was submitted.
- 5.4 The application for the DPS variation was rejected as a person cannot hold the position of DPS if they do not hold a personal licence.
- 5.5 Not only did Mr SHARIF not hold a personal licence at the time of application but the application was wrongly made to Rossendale Borough Council. A personal licence application can only be made to the Licensing Authority in which the applicant is normally resident.
- 5.6 Lancashire Constabulary, on behalf of the Chief Officer of Police, submitted a notice under Section 42(6) of the Act as they are satisfied that the exceptional circumstances of the case are such that granting the application would undermine the crime prevention objective. That notice is appended at <u>Appendix C</u>.

### 6. BACKGROUND

- 6.1 On 22<sup>nd</sup> March 2023, a licensing hearing was held to consider applications for the review of a premises licence and a transfer of licence. The application for review concerned a premises known as Bacup Wines situated at 34 Burnley Road, Bacup, OL13 8AB.
- 6.2 Lancashire Constabulary applied for the review of the licence above and at the time of the application, the premises licence was held by Mr Zahoor Ahmed.
- 6.3 The transfer application was made by Ashia KAUSER.
- 6.4 Lancashire Constabulary, on behalf of the Chief Officer of Police, objected to the transfer application on the grounds of the prevention of crime licensing objective.
- 6.5 Although Ashia KAUSER and Mr SHARIF (the applicant for this hearing) did not hold the premises licence at the time of the determination hearing and the matter concerned a premises other than the one in question today, the matters which gave rise to that hearing solely concerned the actions and activities of the two individuals.
- 6.6 The minutes from that determination hearing are appended at **<u>Appendix D</u>**.

### 7. **RESPONSIBLE AUTHORITIES**

7.1 The Chief Officer of Police is the only responsible authority that can object to the application and that objection is detailed in section 5 of the report and appended at **Appendix C**.

### 8. OPTIONS

- 8.1 Members should consider the application, the representations and all submissions made and must:
  - a) Grant the application; or

b) Reject the application if it is considered appropriate for the promotion of the crime prevention objective to do so.

### 9. POLICIES TO CONSIDER

- 9.1 Rossendale Borough Council's Statement of Licensing Policy effective 20<sup>th</sup> March 2019.
  - Guidance issued under Section 182 of the Licensing Act 2003.

### 10. CRIME AND DISORDER

- 10.1 Section 17(1) of the Crime and Disorder Act 1998 places a duty on the Local Authority to have due regard to the likely effect of the exercise of these functions on preventing in its area, the following;
  - crime and disorder;
  - misuse of drugs alcohol and other substances; and
  - re-offending.

No supply of alcohol may be made under the premises licence at a time when there is no designated premises supervisor in respect of the premises licence or at a time when the designated premises supervisor does not hold a personal licence or their licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### Conditions imposed by virtue of paragraph 6(8) Schedule 8 Licensing Act 2003

Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means:

Between 0800 hours and 2300 hours Monday to Saturday. Between 1000 hours and 2230 hours Sunday. Between 0800 hours and 2230 hours Good Friday. Between 1200 hours and 1500 hours and between 1900 hours and 2230 hours on Christmas Day.

The above restrictions do not prohibit:

During the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;

The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;

The sale of alcohol to a trader or club for the purposes of the trade or club;

The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of state or an authorised mess of members of Her Majesty's naval, military or air forces.

Alcohol shall not be sold in an open container or be consumed in the licensed premises.

No child shall be employed so long as he/she is under the age of 14 years to do any work other than light work or before the close of school hours on any day on which he/she is required to attend school or before 7 o' clock in the morning or after 7 o' clock in the evening on any day or for more than 2 hours on any day on which he/she is required to attend school or for more than 2 hours on a Sunday or more than 35 hours, or if he/she is under the age of 15 years, for more than 25 hours in any week in which he/she is not required to attend school or for more than 4 hours in any day without a rest break of 1 hour or at any time in a year unless at that time he or she has had, or could still have, during the period in the year in which he is not required to attend school, at least two consecutive weeks without employment.

Mandatory Conditions as per The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010

These conditions come into force on 1st October 2010.

- 1. (1.) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
  - (2.) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to do the work in question.
- A current Residence Card issued by the Home Office to a person who is not a national of an EEA state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of an EEA state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their
  permission to be in the UK with the Home Office such as the Home Office
  acknowledgement letter or proof of postage evidence, or evidence that the person has an
  appeal or administrative review pending on an immigration decision, such as an appeal or
  administrative review reference number.
- Reasonable evidence that a person who is not a national of an EEA state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
- evidence of the applicant's own identity such as a passport,
- evidence of their relationship with the EEA family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
- evidence that the EEA national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
  - (i) working e.g. employment contract, wage slips, letter from the employer,

#### carrying on of a licensable activity.

Any premises licence issued on or after 6 April 2017 will lapse if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have the right to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensing activity. They do this by providing with this application copies or scanned copies of the following documents (which do not need to be certified).

### Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is a British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport apply].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A full birth or adoption certificate issued in the UK which includes the name(s) of at least one of the holder's parents or adoptive parents, together with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

(ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,

(iii) studying e.g. letter from the school, college or university and evidence of

- sufficient funds; or
- (iv) self-sufficient e.g. bank statements.

Family members of EEA nationals who are studying or financially independent must also provide evidence that the EEA national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

**Original documents must not be sent to licensing authorities.** If the document copied is a passport, a copy of the following pages should be provided:-

(i). any page containing the holder's personal details including nationality;

Good morning.

Please accept this as the Police objection to the Transfer of Premises License application for 103 Market Street, Whitworth from Gulraiz SHARIF.

On the 3<sup>rd</sup> November 2023 Lancashire Constabulary received an application from Gulraiz SHARIF to transfer the Premises Licence at 103 Market Street, Whitworth.

A check of Police records indicates that Gularaiz SHARIF has previously been the owner of Bacup Wines Convenience Store, 34 Burnley Road, Bacup. This premises was taken to review in January 2023 following a failed test purchase when alcohol was sold to a 16 year old volunteer in December 2022. The test purchase was carried out following reports of under age sales at the premises. The premises licence was subsequently revoked.

We are also aware that Greater Manchester Police, together with Trading Standards, have previously seized illicit tobacco and alcohol from a premises in Bury that was run by the applicant.

Our objection therefore centres on our concerns that Gulraiz SHARIF has previously been the owner of a business where the premises licence was revoked following a failed test purchase of alcohol, he has been the owner of a business where illicit alcohol and tobacco were seized and

It is our view that Gulraiz SHARIF has previously shown and inability to demonstrate he is able to work towards the Licensing objectives of the prevention of crime and disorder **serious** and we have serious concerns that this would continue should he be permitted to take over this premises licence.





### 1. APOLOGIES FOR ABSENCE AND NOTIFICATION OF SUBSTITUTES

There were no apologies for absence.

### 2. CHAIRMAN'S INTRODUCTION

The Chair welcomed all parties to the meeting and asked the members of the Sub-Committee and Council Officers to introduce themselves.

The Chair asked the Applicant; Responsible Authority; Interested Party and Licence Holder to introduce themselves.

### 3. DECLARATIONS OF INTEREST

No declarations were made.

### 4. REVIEW OF A PREMISES LICENCE AND TRANSFER OF PREMISES LICENCE AT: BACUP WINES, 34 BURNLEY ROAD, BACUP, OL13 8AB.

- 4.1 The Licence Holder, Other Party, Applicant, Responsible Authority and Interested Party attended the Hearing with regard to a review of the premises licence and transfer of the premises licence at Bacup Wines, 34 Burnley Road, Bacup, OL13 8AB.
- 4.2 The Legal Advisor outlined the legal issues surrounding the hearing.
- 4.3 There were no representations submitted by any of the parties to hear the matter in private.
- 4.4 The Licensing Officer presented the report.
- 4.5 The Hearing procedure was followed.
- 4.6 The Applicant presented their case.

- 4.7 The members asked questions of the Applicant.
- 4.8 The Licence Holder and other party presented their case.
- 4.9 The members asked questions of the Licence Holder and Other Party.
- 4.10 The Responsible Authority presented their case.
- 4.11 The members asked questions of the Responsible Authority.
- 4.12 The Interested Party made their representation.
- 4.13 The members asked questions of the Interested Party.
- 4.14 All parties provided clarification.
- 4.15 The Licence Holder, Other Party, Applicant, Responsible Authority, Interested Party and the Licensing Officer left the room whilst the committee deliberated.
- 4.16 The Licence Holder, Other Party, Applicant, Responsible Authority, Interested Party and the Licensing Officer returned to the meeting for the announcement of the decision.

### 5. DECISION

5.1 After giving consideration to all the written and verbal representations made today, by the Licence Holder, Applicant, Responsible Authority and interested parties; and after giving proper consideration to the Licensing Objectives, the Sub-Committee appointed under the Licensing Act 2003 decided to take the following action on the transfer application and review of the premises licence for the premises under Section 42 and Section 51 of the 2003 Act

Resolved:

To refuse the transfer application as the Sub-Committee considered it appropriate for the promotion of the crime prevention objective.

In respect of the application to review the premises licence, the Sub-Committee resolved:

To revoke the premises licence for the following reasons:-

- Upon hearing the information submitted by the police and Responsible Authority, it is evident that there have been a number of repeated incidents of underage sales of alcohol and vapes to children.
- Given the number of incidents; the circumstances surrounding the incidents and the fact that the matter involves safeguarding issues relating to young vulnerable minors, the Sub-Committee considered that the seriousness of the incidents and the crimes committed against young children undermines the following Licensing Objectives:-
- 1. Prevention of Crime and Disorder

- 2. Protection of Children from Harm
- They have also considered the written and oral representations submitted by all interested parties and the concerns raised therein.
- Through the information presented by Ms Kauser and Mr Sharif, it is clear that their understanding of the Licensing Act and Guidance is inadequate and has not been complied with. It was also noted that since the incidents took place, no additional measures have been put in place to prevent underage sales; to protect children from harm and to prevent crime and disorder.

This decision has been made because the Sub-Committee are satisfied that these measures are necessary to satisfy the aforementioned licensing objectives, namely:

- 1. Prevention of Crime and Disorder
- 2. Protection of Children from Harm

A determination notice would be served on all parties in due course.

There was a right of appeal for all parties before the Magistrates' Court which must be exercised within 21 days on receipt of the Decision Notice.

### The meeting commenced at 10.00am and finished at 12:21pm.
