- The Strategy details the Council's contribution to improving the lives of older 4.1 people and how it will deliver on some of the key outcomes which are identified as improving the lives of older people:
 - Financially and materially secure
 - Accessing mainstream services
 - Making a positive contribution
 - Healthy and Well
 - Safe and supported
- 4.2 Lancashire Partnership are producing a strategy for an ageing population based on the five outcomes above. The development of the strategy was an action identified in the county's community plan 'Ambition Lancashire'. Each of the outcomes have aims which address specific issues such as transport,

employment, feeling safe and so on. The strategy is designed to respond to Lancashire's ageing population. The strategy is currently under consultation.

- 4.3 The strategy will be an overarching plan for all services for older people in Lancashire. All partners are expected to sign up to the strategy and make a valuable contribution in addressing the needs of an ageing population.
- 4.4 The Strategy cannot be considered in isolation, it is linked to other plans and strategies including the Community Strategy and the Local Area Agreement priority outcomes. The Strategies delivery mechanisms are service focused Business Plans which focus of the activities the Council will deliver on the over the next three years.
- 4.5 To support the involvement of Older People and to ensure that we are able to delivery services for an ageing population it is important that the Borough Council develops its own Older people's Strategy.
