### 1. PURPOSE OF REPORT

1.1 To recommend to Cabinet the decision of the Overview and Scrutiny Management Committee in respect of the Review of Litter Bins in the Borough.

### 4. BACKGROUND AND OPTIONS

4.1 A scrutiny form was completed by an Elected Member who raised concerns about litter bins in the Borough. It was agreed by the Policy Development Overview & Scrutiny Meeting on 20 July 2006 that this matter be taken forward for review through a Task and Finish Group. It was also agreed that this would be a 'light touch review' as Members were conscious of other pieces of work within the programme that were still to be undertaken.

The Group's objective was to look at the varying styles, sizes and number of bins within the Borough and the need to ensure that the approach was consistent and to;-

- i) Determine the criteria for provision of litter bins
- ii) Determine the most appropriate type of provision
- ii) Identify means of encouraging local businesses to take responsibility for litter generated as a result of their activities

The Group discussed how to take this work forward and agreed that, as the Council had an existing database of all the litter bins in the Borough, a survey examining the location and condition of the bins would be the ideal way to commence with this project.

All Elected Members were given the opportunity to participate and were asked to go out into their particular ward with the list of identified litter bins within the ward and complete a questionnaire.

### 5. COMMENTS OF THE HEAD OF FINANCIAL SERVICES

5.1 The new Capital Programme (to be approved by Council) includes a sum of £80k, which amongst other things, is to be used for additional litter bins.
