1. PURPOSE OF REPORT

The purpose of this report is to:

- inform Overview and Scrutiny about the policy on Grants to Outside Bodies which it reviewed in February 2006
- inform Overview and Scrutiny of the proposed allocations for 2007/8
- inform Overview and Scrutiny about the impact of Council grants allocated to outside bodies in 06/07.

3. RISK ASSESSMENT IMPLICATIONS

The evaluation report will enable the Council to build up a picture of the impact of our grants policy. By increasing our understanding of what kinds of projects have worked well and what has been less successful, we are better able to assess future applicants' proposals and advise them on how their applications can reflect best practice.

4. BACKGROUND/REASON FOR REPORT

4.1 In February 2006 Overview and Scrutiny received a report on the new policy for distributing grants to external bodies and voluntary sector organisations.

This report includes a copy of that previous report and an update on the allocation of grants in 2006/7 and proposed spend in 2007/8

Grants to outside bodies are £216,262 for 07/08 which represents 1.9% of RBC's total budget for 2007-08 of £11,199,000.

4.2 Organisations from the Voluntary, Community and Faith sector were invited to apply for Council grants in December 2005. Grants were awarded to organisations that were able to demonstrate their ability to add value to services needed by the communities in Rossendale and which complemented the Council's Corporate Objectives and those of the Local Strategic Partnership (LSP), the Rossendale Partnership.

All organisations awarded a grant were also required to sign a funding agreement which set out the amounts awarded, what the funding has been awarded for and the outcomes and outputs to be achieved.

4.3 **The Monitoring and Evaluation Process**

In January 2006 organisations were required to complete a monitoring and evaluation form on the progress of the project/services being delivered as a result of the funding awarded to them. The form asks whether they had achieved the outputs and outcomes as agreed in their funding agreements, as well as reporting on the number of beneficiaries or service users and any problems that had occurred.

4.4 Results of Monitoring and Evaluation 2006/07

- In 2006/07 a total of £215,614 was awarded to 28 organisations from the voluntary, community and faith sector. The original budget allocated for 06/07 was £220,450, however the funding for North West Arts Board was removed from the grants policy and funded through alternative budget.
- Of the total awarded there remains £14,546 of money unspent. This does not however, include the payment to Age Concern (£1000) and Whitworth Historical Society (£2900) for their rent which was agreed in previous years – this will be spent by the year end.

- Members should note that Spurgeons were allocated a budget spend of up to a maximum £33,845. However the projected spend up to March 07 is £23,199 resulting £10,646 of the saving.
- This advisory group has already agreed to recommend that this under spend is carried forward into the next years budget in order to support further grant giving opportunities though area forums.
- There are still 8 organisations that are yet to spend all the money awarded to them. Sunnycrest is the only organisation that has **not spent any** of the money awarded to them. However all these organisations have indicated that the remaining money will be spent by 31st March 07. See appendix 1. The Partnerships Support Officer will be working to ensure that all spend is delivered on time.
- Members will be aware that the funding agreement allows for claw back of unspent allocated grants.
- The types of projects/services funded by the Council and the purpose of the funding can be viewed in appendix 1. Housing support, victim support, advice on debt and benefits and environmental projects are just some of the services/projects funded by the Council. The grants awarded also reflected the diversity of the Borough.
- The purpose of the funding can be split into two categories:
 - 1. Funding to maintain current services by paying for rent, buying equipment or salary of employer.
 - 2. Funding to deliver specific projects.
- The beneficiaries of the funding provided by the Council can been viewed in appendix 2. The main beneficiaries were young people. Also families, BME groups, people with disabilities, victims of crime, people in debt, are just some of the other beneficiaries of the Council grants.
- Older people appear to have experienced little benefit from the grants awarded.
- The full outcomes of the funding provided by the Council can be viewed in appendix 2, however, a sample include:
 - The Credit Unions have helped to reduce financial exclusion by providing easy repayment loans to those in financial difficulties.
 - The CAB has dealt with over 5 million pounds worth of debt in the calendar year ending 31/12/06.
 - Burnley Women's Refuge are continuing to provided vital support to women and children and risk of domestic violence. Four families from Rossendale have been accommodated in Burnley Refuge centre.

- The Family Centres in Bacup and Whitworth have undertaken various activities for families ranging from playgroup sessions, family day trips and after school clubs. The centres are helping to enhance parental skills and strengthen family ties.
- Over 80 victims of crime have received personal support. These are just some of the outcomes achieved.
- Some organisation did experienced difficulties in delivering their projects/services. Recruiting and retaining volunteers and limited funding sources were stated as the main constraints on service/project delivery. We will work with our partners at REAL, the Community Network and Council for Voluntary Services to help overcome these problems in future years.
- Organisations were asked whether the Council gave all the money they needed to deliver their project/services. Of the 26 organisation that received payment, only 7 said that the Council gave all the money required. Those that said no were able to obtain further funding from other funding bodies or used money donated to them. See appendix 3
- Of the 26 organisations that received payment, only 13 carried out satisfaction surveys with service users. See appendix 3 and only two organisations asked non users why they don't use their projects/services. However this was only in the form of verbal feedback. We are hoping to increase these figures in future years however, not all grants are suitable for this sort of analysis.

5. OPTIONS CONSIDERED

5.1 All applications have been considered and are detailed at appendix 4.

6. COMMENTS OF THE HEAD OF FINANCIAL SERVICES

6.1 There is a allocated sum of money for grants to the voluntary sector set aside within the council's budget.

1. 2006/07 Grants Applied for and Allocated

It was reported that the budget allocated for grants in 2006/07 was £200,450. An additional £20,000 was carried forward from 2005/06. In total £220,450 was made available for grants to outside bodies in 2006/07

Spurgeons were allocated a grant up to a maximum £33,845. However after careful review of their spending only £24,764 was given to the organisation.

The projected under spend on grants for 2006/07 is £9,517.

It was mentioned that the grants report that went to Cabinet last year indicated a total of $\pounds 260,000$ of funding available funding for 2006/07. However it was clarified that the total sum of $\pounds 260,000$ included a number of organisation which the Council continues to fund but not under the grants policy. These organisations are now funded through an alternative budget channel. The organisations are:

- SCOSPA (Pennine Prospects)
- East Lancashire Partnership
- Rossendale M3 Project
- North West Arts Board.

2. Grants Committed 2007/08

Subject to budget approval the total that will be made available for grants in 2007/08 will be £204, 262 plus the additional 9,517 carried forward from 2006/07. In total £213, 779 will be allocated into the grants budget for 2007/08.

The Grants Advisory Group has already committed a total of £178,960 to voluntary and community organisations for 2007/08.

The total uncommitted for 2007/08 is £34,819.

3. Proposal for expenditure

In addition to the £178,960 already committed to in 2007/08, it was proposed that we also fund the following organisations in 2007/08.

- Burnley, Pendle and Rossendale Council for Voluntary Services (BPR CVS) £5,000
- Friends of Bocholt £1,000.
- Mid Pennine Arts £4,676.

If the Grants Advisory Group agree to fund the following three organisations the total uncommitted for 2007/8 will change to £24,143.

The grants advisory group agreed that we should not fund Mid Pennine Arts as most of their activities are not focussed in Rossendale. The benefits gained from funding this organisation are minimal.

Action: Ilona to investigate how we intend to stop funding Mid Pennine Arts for future years.

The Grants Advisory Group agreed that we fund BPR CVS and Friends of Bocholt as proposed.

Assuming that we do not fund Mid Pennine Arts the total uncommitted for 2007/08 will be £28,819.

There was a discussion about our funding agreement with Citizen Advice Bureau. For 2007/08 we have committed to fund CAB a total of £75,000. It was proposed that we should review the amount we intend to give to the CAB.

Action: Ilona to ask chair of Overview and Scrutiny to review the total amount the Council intends to award to the CAB.

4. Proposed recommendation for uncommitted funds 2007/08

It was suggested that it would be inappropriate to open a grants bidding round for outside bodies for 2007/08 as we only have a small amount of uncommitted funds.

The recommendation was to allocate a total of £20,000 to each of the four Area Forums (£5,000 each) with the remaining amount put aside for contingency funds.

The Grants Advisory Group agreed that this would be the best way forward.

Action: Ilona to write report for Cabinet and Full Council in March 2007 setting out the recommendation agreed by the Grants Advisory Group.

The Grants Advisory Group also agreed to meet in November 2007 to review the grants process.
