1. Purpose of Report

- 1.1 The purpose of the report is to provide the Council with notice of the Draft Statement of Community Involvement (SCI), its current consultation and amendments to that document following the representation received.
- 1.2 This report follows information provided in Item F5 (Appendix B) of the Overview and Scrutiny meeting held on 8th August 2005.

2. **RECOMMENDATIONS**

2.1 That Council endorse the document which is out for consultation.

3. REPORT AND REASONS FOR RECOMMENDATIONS AND TIMETABLE FOR IMPLEMENTATION

- 3.1 Like the Local Development Scheme a Statement of Community Involvement (SCI) is a technical based document. It shows how and when planning authorities intend to consult local communities and other stakeholders when preparing documents. A key outcome of the SCI will be to encourage 'front loading' this means that consultation begins at the earliest stages of a document's development so that communities are given the opportunity to be involved and to make a difference. A copy of the draft is set out at Appendix 1.
- 3.2 A Statement of Community Involvement must provide good levels of access to information and identify methods of consultation that it can deliver. It should be designed to increase the opportunity to create understanding of the planning system and actively encourage communities to contribute ideas and representations, and for Rossendale to provide regular and timely feedback.

3.3 Further opportunity for consultation will be provided during the submission stage of the document in during December 2005. This stage will provide an additional 6 weeks for representations to be received upon submission to the Secretary of State.

4. MEMBER DEVELOPMENT AND POLITICAL ARRANGEMENTS

4.1 Members are encouraged to read the Local Development Framework briefing note Attached to this report and to visit <u>www.planningportal.gov.uk</u> to gain greater understanding of planning issues. 4.3 The methods of consultation identified in the Rossendale SCI is largely determined by its capacity to deliver the methods of communication and consultation identified in the document. Therefore the Council will need to consider whether any further improvements or additional forms of consultation identified through the consultation process are deliverable through the existing structure and capacity of the Forward Planning Team.

It is a statutory requirement that the SCI is put out for consultation. The regulation states that the consultation period should be for no less than 6 weeks.
