## **NOTES:**

- 1. Any person who knowingly and willfully makes a statutory declaration which is false in a material particular is guilty of an offence and liable to conviction, to a term of imprisonment for a period of up to 2 years or to a fine or to both (Section 5 of the Perjury Act 1911).
- 2. Failure to disclose convictions, cautions and pending prosecutions, can be taken into account when assessing the suitability of hackney carriage and private hire drivers to be licensed or continue to be licensed.
- 3. If you have declared any convictions, or should information be received from the Criminal Records Bureau (CRB) indicating that you have convictions, which you may or may not have declared, then your application will be considered by members of the Licensing Committee. More information will be given to you in the event of this happening.
- **4. Note to solicitor / commissioner for oaths:** Please would you remind the applicant that it is not a true declaration unless he/she has completed the table overleaf, giving details of all convictions and cautions if so required. Please write on the back of one of the applicant's photographs the words "I certify that this is a true likeness of [applicant's name]" and sign and date.
