1. WELCOME AND INTRODUCTIONS

The Chair welcomed members of the public to the meeting.

2. APOLOGIES

Apologies for absence were submitted from Inspector Dave Hodson, Lancashire Constabulary.

3. NOTES OF LAST MEETING

The notes of the meeting held on 25th June 2007 were agreed as a correct record.

In response to a question by a member of the public about overgrown shrubs on Oaklands Drive David Whiteman reported that the pruning of shrubs was the responsibility of Lancashire County Council and their programme of works was behind schedule due to wet weather conditions.

PC Gareth Henderson reported that additional speed cameras were to be sited in the borough, although specific locations were not confirmed.

Councillor Forshaw expressed her concern about the disturbance and refuse left on highway verges by contractors in Rawtenstall. She requested a list of council staff associated with cleansing, in job title order, so that she would know who to contact regarding similar issues.

IT WAS AGREED - That the Chair would ensure a staff list, detailing job responsibilities, was circulated to all members.

4. POLICE UPDATE

Paul Lee, Community Sgt at Rawtenstall, updated the Forum on policing in Rawtenstall.

He informed that there had been reductions in all crime in Rawtenstall, including criminal damage, antisocial and violent behaviour. Operation vault was currently underway and targeted cash in transit robberies. Operation summer nights had now finished.

In response to a question by a member of the public, Sgt Lee explained that the new operations unit was expected to be based at Waterfoot and a base for Community Officers would be retained in Rawtenstall.

In response to questions by Councillors, Sgt Lee informed that policing levels in the evening would be adjusted and targeted in response to police intelligence. He further informed that where there were problems with loading outside businesses in the town centre the police would issue fines where this was possible, but that there may also be planning matters that are the remit of the Council.

5. Hot Topic – Determining of Grant Allocations

Councillor Swain reported that the Working Group had met to consider the applications for Neighbourhood Forum funding. He informed the meeting that £3.5K had been allocated and the remainder of the funding (£3.76K) would be allocated at future meetings. The Working Group was recommending approval of the following:

6. **NEAT Update**

Dave Whiteman, NEAT Manager, reported on the recycling roadshows that were taking place across the borough during the week, emphasising the one on Saturday 29th September between 10.00am and 12.00 noon at Rawtenstall market. He explained that this was part of the work being carried out to increase recycling within the borough.

In response to a complaint by a member of the public about rubbish being put into bins by persons other than the bin owner, Mr Whiteman stressed that the NEAT team and refuse operatives want to work with the public and help them and that fines would only be used as a very last resort.

Councillor Forshaw commented that further, clear and friendly, guidance on recycling should be issued to households.

In response to a question from Councillor Forshaw, Mr Whiteman reported that regular visits to schools were made in which work was done to encourage and educate children about recycling. He stated that these visits were well received by children and several schools in the borough were designated 'eco schools'.

In response to a question from Councillor Gill, Mr Whiteman explained that assistance was available to persons were not able to physically put out their bins. They could access this service by contacting the refuse or NEAT teams.

7. Open Forum

A summary of the questions raised during public question time are detailed below:

A member of the public complained about the frequency of gully cleaning on Barnes Avenue, Schofield Road and Barrat Road. He was concerned that this may cause serious accidents. The person was advised that this was the responsibility of the County Council.

Several attendees wished to congratulate the Rawtenstall Town Centre Caretaker on the good job they are doing.
