1. APOLOGIES FOR ABSENCE

8. UPDATE TO MEDIUM TERM FINANCIAL STRATEGY

9. REVENUE BUDGET AND COUNCIL TAX FOR 2008/09

The Portfolio Holder for a Well Managed Council presented an update to Appendix 4 of the Report relating to the 2008/09 Precepts and asked Council to note the Lancashire Police Authority (General Expenses) Precept was £2,924,021.

In considering the Report Members identified the following issues to which the Leader of the Council or Portfolio Holder for a Well Managed Council responded.

- Free access to leisure facilities, this would now include reservists
- Investment in Council vehicles

Councillor Aldred moved the following addition to the Report by way of an amendment which was seconded by Councillor A. Barnes:

"That the Independent Remuneration Panel be requested to undertake an urgent review of the Members Allowances Scheme".

On being put the amendment was carried, and the substantive motion was then put.

Resolved:

That the Independent Remuneration Panel be asked to consider the 2008/09 Members Allowances Scheme being based on 15 hours per week as the average number of hours on official council duty and that if any Councillor that undertakes less than 15 hours be given the opportunity to forfeit the allowance.

1 - Budget Requirement

- 1.1. That the savings (and use of funds) identified for 2008-09 in the sum of £240,000 as detailed in Appendix 2 of this report be approved.
- 1.2. That investments in the sum of £126,000 as detailed in Appendix 2 of this report be approved.
- 1.3. That an amount of:
 - 1.3.1. £37k be transferred from the Change Management Reserve,
 - 1.3.2. £112k be transferred from Local Authority Business Growth Incentive Scheme (LABGIS)

1.4. That consequent upon resolutions 1.1, 1.2, and 1.3 above, and the Head of Finance opinion on the robustness of the 2008-09 Estimates and the level of balances, the Council's Budget for 2008-09, as amended, be approved in the sum of £11,504,246.

3 - Council Tax Base

- 3.1 That it is approved that in accordance with the delegation, of 9th January 2008, the Head of Financial Services in consultation with The Leader of the Council calculated the following amounts for the year 2008-09 in accordance with Section 33 (1) of the Local Government Finance Act 1992, as amended by Section 84 Local Government Act 2003 for the whole area of the Borough the 21,506 "D" Band equivalent units being the amount calculated by the Council, in accordance with Regulation 3 of the Local Authorities (Calculation of Council Tax Base) Regulations 1992, as its Council Tax base for the year end,
- 3.2 For that part of the Council's area being Whitworth Parish, the amount be 2,326 "D" Band equivalent units, being the amounts calculated by the Council in accordance with Regulation 6 of the Regulations, as the amounts of its Council Tax for the year for dwellings in that part of its area to which the Special Items relate.

4 - Budget impact on Council Tax

- 4.1 That the following amounts be now calculated and approved by the Council for the year 2008-09 in accordance with Sections 32 to 36 of the Local Government and Finance Act 1992:-
 - (a) £32,979,796 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(2)(a) to (e) of the Act.
 - (b) £21,475,550 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(3)(a) to (c) of the Act.
 - (c) £11,504,246 being the amount by which the aggregate at 4.1(a) above exceeds the aggregate at 4.1(b) above, calculated by the Council, in accordance with Section 32(4) of the Act, as its budget requirement for the year.

- (d) £6,208,178 being the aggregate of the sums which the Council estimates will be payable for the year into its General Fund in respect of redistributed Non-Domestic Rates, Revenue Support Grant, (increased by the amount of the sums which the Council estimates will be transferred in the year from its Collection Fund to its General Fund in accordance with Section 97(3) of the Local Government Finance Act 1988 (Council Tax Surplus) or (reduced by the amount of the sums which the Council estimates will be transferred in the year from its General Fund to its Collection Fund in accordance with Section 97(4) of the Local Government Finance Act 1988) (Council Tax Deficit)
- (e) £Nil being a transfer from the Collection Fund Surplus to General Fund.
- (f) £246.26 being the amount at 4.1(c) above less the amount at 4.1(d) and 4.1(e) above, all divided by the amount at 3.1 above, calculated by the Council, in accordance with Section 33(1) of the Act, as the basic amount of its Council Tax for the year.
- (g) £49,966 being the aggregate amounts of all special items referred to in Section 34(1) of the Act.
- (h) £21.48 being the amount at 4.1(g) above all divided by the amount of 3.2 above, calculated by Council and applicable to the Parish of Whitworth area only for the Special items.

- 1. That the Deputy Mayor is selected based on length of service and not political affiliation.
- 2. That members seeking re-election at the following May election be considered for nomination, subject of course to their re-election.
- That a Selection Committee comprising of the Leaders of each Political Group meets in December of each year to consider members who could be eligible for selection.
- 4. That the selection of Deputy Mayor be made following the RBC elections in May except in the year of the LCC election when the selection should be made by the Selection Committee at its meeting in the previous December.
- 5. To allay any fears that this Notice of Motion could be politically motivated, that the selection of the Deputy Mayor for 2008/2009 should be restricted to members of the Conservative group.
- 6. That the Deputy Mayor will automatically be voted Mayor in the following year.

Councillor Swain moved the following amendment which was seconded by Councillor Eaton:

"That the criteria relating to the selection of Deputy Mayor be referred to the Civic Matters Working Group for consideration and that a report be submitted to the Council on 26th March 2008".

On being put the amendment was carried and the substantive motion was then put.
