These indicators are designed to identify the total expenditure spent by the authority on advice and guidance. The indicator is split into three.

- 1. The main problem with calculating these PIs is that the exact figure is very difficult to calculate. The definition of advice and guidance is extremely broad. It includes amount spent on information the public access theme selves e.g. leaflets, booklets, website. It includes amount spent on assisting the public find information e.g. advice on where to obtain further help e.g. staff time, advice surgeries. It also includes general help where specific organisation give advice e.g. Citizen Advice Bureau. Due to its broad definition it is difficult to calculate, The information required for these PI are also extremely time consuming to collate I can't see what added value this brings to the Council.
- 2. BV226a measures expenditure spent on advice and guidance provided by external organisations e.g. Citizens Advice Bureau and Age Concern. Please refer to concerns above. Also Capita provide advice through benefits service but they do not collect information on how much they spend on advice and guidance alone. Any information provided by Capita are very broad estimates.
- 3. BV226b looks at how many of these organisations have CLS quality marks. A large number of voluntary and community organisation that provide advice are small and probably don't have the funding or capacity to work toward a national quality mark. It is more important to ensure that any organisation we fund comply with the Council's grants policy and complete a monitoring an evaluation form to ensure that the work carried out this fit for purpose. This is what we already do.
- 4. BV226c measures the total amount spent on advice and guidance in the areas of housing, welfare benefits and consumer matters which is provided directly by the authority to the public please refer to concerns in point 1. The Council does not monitor specific spend on advice and guidance in these areas and any information collated is based on broad estimates.
