#### 1. PURPOSE OF REPORT

1.1 To update members on the Pride in Rossendale initiative.

#### 2. CORPORATE PRIORITIES

- 2.1 The matters discussed in this report impact directly on the following corporate priorities and associated corporate objective.
  - Delivering Quality Services to Customers (Customers, Improvement)
  - Delivering Regeneration across the Borough (Economy, Housing)
  - Keeping Our Borough Clean and Green (Environment)
  - Promoting Rossendale as a cracking place to live and visit (Economy)
  - Improving health and well being across the Borough (Health, Housing)
  - Well Managed Council (Improvement, Community Network)

#### 4. BACKGROUND AND OPTIONS

- 4.1 Pride in Rossendale is about encouraging people who live, work and visit Rossendale to get involved in improving the local environment. It provides an innovative approach to delivering services in partnership through a range of initiatives.
- 4.2 The projects overarching principle is to work alongside members of the public, schools, businesses, public and private sector organizations and community groups in order to achieve the following objectives:
  - To increase awareness and develop personal responsibility for the environment.
  - To involve schools, residents, businesses and community organizations in taking direct action to improve the physical environment through various campaigns and initiative.
  - To encourage and advise on the development of community led environmental projects.
  - To raise public awareness of the Council's focused approach to Neighbourhood engagement.
- 4.3 Some potential projects may include; bulb planting with school students, community groups, businesses, supporting residents groups to improve the appearance of their streets with floral hanging baskets and improve the visual impact of people entering Rossendale by improved signage.
- 4.4 The project is also about demonstrating that Rossendale Council has listened to local people who are proud of where they live and want to work with us to encourage more people to take Pride in Rossendale.

#### 5. GOVERNANCE OF PROJECT

5.1 A working group has been established comprising:

5.2 <u>Terms of reference</u> have been agreed with the group whose aim is to oversee the project, agree the project plan and monitor actions. It is envisaged however, that as the project evolves the actions will be monitored via Neighbourhood forums.

#### 6.0 WORK PROGRAMME

- 6.1 Work has already commenced with the following being identified as forming part of the pride initiative.
  - Continuation of litter bin replacement.
  - New (recycled plastic) bench, notice board programme.
  - Promotion programme in relation to litter, dog fouling, fly tipping.
  - Train and empower Rossendale staff and police (PCSO'S) to take a proactive approach and where appropriate take action against those individuals who fly tip and drop litter.
  - Improving war memorials.
- 6.2 In addition to the above, the following are planned, subject to cabinet approval for 2009/10.
  - <u>Members Grot-Spot competition</u> December 2008 for implementation in January 2009.
  - <u>Launch a Community Pride project</u> in spring 2009 asking communities what they would like to see changed in their street or road. Pride would provide funding, for example rubbish bags, plants, but the community would self manage and lead the project.
  - <u>During May-July 2009 Working with Schools</u> (target nine primaries and two secondaries) to raise awareness about litter and dog fouling. Initial feedback from schools has been really positive.
  - <u>Rossendale Improvements to Gateways and high visible routes</u> <u>Programme</u> to be agreed on neighbourhood area by area basis. Will include daffodil, flower beds, other plant related work and joint highway sites. Lancashire County highways have confirmed a commitment to contribute funding for the joint highways sites.

Sites identified and member consultation meetings organised in December/January to confirm or amend. The Portfolio Holder for the Environment in consultation with the Chair of the Neighbourhood Forums to formally sign off the programme following consultation.

• <u>Gateway Signs and Maintenance</u> Audit gateway signs and make recommendations for improvement. Explore opportunity to attract sponsorship on signs.

- <u>Business Sector Engagement</u> Explore business specific newspaper and develop in consultation with partners a "Buy Local" campaign.
- <u>Develop an award scheme</u> which will recognise and celebrate the work/contribution of individuals and community groups.
- <u>Improvements to planting schemes</u> in cemeteries to ensure plant coverage throughout the year instead of the existing seasonal cover.
- 6.3 All of the above project elements are contained within the allocated budget. The challenge is to ensure long term sustainability and each of the projects, ie planting scheme, gateway signs will need to address long term sustainability issues.

6.5 The spend profile has flexibility to enable additional scheme to be developed in 2009 onwards following ongoing community engagement. In addition to the above initiatives the Council and its Offices (ie Property Services and Parks) have given particular focus on the district's 4 main cenotaphs. With that in mind the cenotaph at Rawtenstall Memorial Gardens has seen the recent addition of a flagpole and notice board at a cost of c £1.5k. All the four sites have had some refurbishment work and cleaning prior to Remembrance Day at a cost of c £2.8k. In addition the Park Operations team have given the surrounding grounds area additional attention, again in particular during the period leading up to Remembrance Day.

#### 7. COMMUNICATION AND ENGAGEMENT PLAN

- 7.1 Key elements of the plan include regular updates and engagement at the Neighbourhood Forums with the following key activities contained within the plan:
  - Website page and Pride email address (<u>www.rossendale.gov.uk/prideinrossendale</u> email pride@rossendalebc.gov.uk)
  - Publicise using Council vehicles, and equipment.
  - Engagement plan with press.
  - Regular briefing to be emailed to members and key contacts.

#### 8. MONITORING AND EVALUATION

8.1 The project will be monitored via the working group and Neighbourhood forums. In addition the following basket of indicators has been identified in order to benchmark where we are now and progress achieved through the forthcoming years.

1.	Percentage of people who feel that they belong to their neighbourhood.
2.	Civic participation in the local area (% of residents who are part of a group which makes decision that affect local area.
3.	Overall/general satisfaction with local area.
4.	Improved street and environmental cleanliness (levels of graffiti, litter, detritus and fly posting) (LAA).
5.	Improved street and environmental cleanliness – fly tipping.
6.	Pride Awards – measurement of applications.

- 7. Community clean up days. measurement of activity
- 8. Improved positive press publicity measurement of activity
