#### 1. WELCOME AND INTRODUCTIONS

The Chair welcomed members of the public and asked Elected Members and Officers to introduce themselves to the meeting.

## 2. APOLOGIES

Apologies for absence were received from Councillor May.

# 3. NOTES OF LAST MEETING

- a) The notes of the meeting held on 26<sup>th</sup> January 2009 were agreed as a correct record.
- b) Action sheet:

Updates were given on actions from previous meetings.

In response to questions from Elected Members it was agreed that:

- An update on repairs concerning the coping stones on Ormerod St would be given.
- The ownership of Lord Street and the issue of the road only being tarmacced half way be revisited.

• A list of organisations who had not provided receipts after being awarded funding from the Forum would be sent to the Working Group.

### 4. POLICE UPDATE

Inspector Hodson updated the Forum on Police matters and crime statistics for Rossendale West. Partnerships were working well and over the last 4 years crime figures had reduced.

Inspector Hodson informed the meeting that most crimes in the Rawtenstall area had reduced when compared with the same period last year as follows:

Inspector Hodson informed the Forum of initiatives currently taking place or planned over the next few months. He also reported that overall Rossendale West had seen a 15% reduction in crime over the last year.

- Partnership working with Children's Homes, residents and the Police.
- The new Waterfoot Police Station and parking.

- Opening times of stations.
- Parking issues and Parkwise.
- Wagons backing out onto main roads.
- CCTV on Bank Street.
- The status of the Riverside Car Park.

In response to questions from members of the public and Elected Members it was agreed that:

- The issue with speeding on Haslingden Old Road would be taken up directly with the member of public.
- Inspector Hodson would try to introduce the new Community Beat Officer at the next meeting.

### 5. CREDIT CRUNCH

David Presto, the Economic Development and Senior Funding Manager presented an outline of available support to startup and existing businesses and individuals. The following were outlined:

### 6. POLICY UPDATE ON BINS

Councillor Swain noted that an update had been circulated at the Forum regarding the current position in relation to replacing green bins. The information was in response to a query being raised at the previous 2 meetings and clarified the policy position at the present time. He also informed the Forum that each case would be looked into on its own merits and circumstances.

Members of the public and Elected Members discussed the following issues:

- Damaged/stolen bins at the roadside collection point.
- People with more than one bin.
- House insurance which does not cover wheelie bins.
- Numbers of bins being replaced, charged for or stolen.
- Policies of other councils.
- Ownership of bins.
- System of appeal.
- Free recycle bins.
- Fly tipping.

In response to questions from members of the public and Elected Members it was agreed that:

 Information on numbers of bins replaced and numbers stolen would be obtained along with confirmation on ownership of bins.

### 7. AREA MANAGER COMMUNITIES UPDATE

The Area Officer introduced herself and gave an update on the Communities Team activities.

The Area Officer outlined the recent work undertaken by the team including the allocation of 90 litter bins as part of the Pride in Rossendale initiative. She also informed the Forum that a Pride in Rossendale postcard had been circulated and invited members of the public to send in their ideas on improving the area.

Members of the public and Elected Members discussed the following issues:

- Waste collection vehicles and a Waste Transfer Station.
- Funding to acquire land and build a Waste Transfer Station.
- Planning permission for a Waste Transfer Station.
- Functions at Henrietta Street.
- Who to speak to about Waste Transfer.
