1.1 Inform Cabinet of the ongoing work in relation to the Lancashire County Council's Public Realm Integration Project.

4 BACKGROUND AND OPTIONS

4.1 The "public realm" is best described as "a fence to fence" service, covering e.g. highways, grass verges, trees and shrubs, street lights, signs, street furniture

and litter. These are issues that matter to local people and that are important in defining a positive sense of place.

- 4.2 In the current two-tier structure these services are delivered by both Lancashire County Council and the District Councils. Whilst this has the potential for disjointed delivery and a lack of accountability the reality is that the public don't care who delivers the services, only that they are to a good standard and provide value for money.
- 4.3 In recognition of this challenge, Team Lancashire sponsored a pilot project to improve integration between Lancashire County Council and Burnley and South Ribble Borough Councils. Whilst the pilot works with Burnley Borough Council focused on strategic planning issues, the South Ribble Borough Council pilot focused on Streetscene/public realm services. This pilot has been evaluated and is widely seen as being a success and it is intended to develop this work further and roll this out to all 12 District Councils.
- 4.4 The pilot work at South Ribble Borough Council focused on the 'clean and green agenda' and this is seen as phase one of the public realm project. Learning from the pilot made it clear though that this does not capture all the areas of interest/concerns from the District Councils and therefore the project is defined into the following phases:
 - Phase 1 clean and green (as above).
 - Phase 2 public realm management, including signage, street Furniture, street clutter and removal of obstructions.
 - Phase 3 safe and sustainable communities with a focus on better integration of enforcement and inspection regimes.
 - Phase 4 strategic planning.
- 4.5 The report is recommending that officers commence detailed discussions with the County Council in order to understand how the project will work and importantly to agree a process of member and wider stakeholder engagement. A further report will be presented to Cabinet in due course once the operational and financial implications are known. In addition it is intended to discuss with Green Vale Homes to assess if they can contribute to the project.

Furthermore, it is anticipated that these same benefits, along with the opportunity to improve the quality of services offered by Rossendale, would assist in delivering some of the recommendations of the Grass cutting task and finish group.
