ROSSENDALE BOROUGH COUNCIL PLAY STRATEGY.

REVIEW OF OVERVIEW (EXEC. SUMMARY) TO PRODUCE 3 YEAR PROGRAMME OF WORKS 2010 – 2013.

Aim:

The overview of the Rossendale Play Strategy condenses the information held within the full play strategy in to annual action plans. This report aims to use this information to develop the actions for implementation over the next three years (2010/11 to 2012/13) on items where RBC will be the lead organisation.

Objectives:

Review previous years action plans (year 1 and 2) – identify what items are outstanding and highlight reasons for this.

Review current years action plan (2009-10) – identify what is still achievable and what may not be possible.

Establish if any budget still exists to complete all or part of the outstanding projects.

Consider next three years action plans – what is achievable and what may not be possible.

Method:

Review the overview document year by year and match against completed projects to establish progress. Note which projects have not been completed then investigate and state the possible reasons for this.

Consider the current years progress, again noting which projects have not been completed then investigate and state which are still due to be completed and which may need to be deferred or cancelled with reasons.

Consider future projects as documented and produce a three year plan of those projects which are still viable while noting which are unlikely to be completed with reasons and which have already been done.

(Note: only projects whereby RBC take the lead are included in this report)

Whitaker Park – Phase one boundary improvements through gift in kind work. £0 required.

Edgeside Park – installation of seating within play area £800.

Whitaker Park has given us insight in to general requirements prior to further
applications. Continue improvements as an action over the next three years
but no green flag achievement.

Section summary:

In this current year the upgrade of Hill Street Play ground, Crawshawbooth and Helmshore Park is still planned. All other works shown as wider park improvements with an aim to achieving green flag status should be implemented but in the form of drawing up draft management plans detailing short term works, medium term maintenance / management requirements and long term vision. Only once this has been completed ad some works implemented can application for green flag award be considered. This is the situation for all parks where green Flag is an aspiration and therefore the green Flag awards should be treated as a separate item of project work to the rest within the play strategy.

The current RBC budget remaining and available to spend this year is £ 52,523

Hill Street was estimated at £100,000 with RBC contribution of £30,000.

Helmshore Park was estimated at £400,000 for all works including green flag with RBC contribution of £10,000.

Also note that Britannia MUGA still requires installation and so far £43,030 has been spent on this project, effectively leaving only £12523 for the MUGA if to retain the planned £40,00 required for the above projects.

SECTION 3: THREE YEAR ACTION PLAN

Within the overview / executive summary of the play strategy there is a section showing two tables: action plan 2010-2015 and action plan 2015 – 2020.

On reviewing these tables in conjunction with our play inspector it is apparent that some of the projects listed have already been completed due to availability of funding. These projects are:

- Ratcliffe pocket park (2012-13). The equipment has recently been updated and repairs to the wall as well as tree work on site now mean that this park is in good condition.
- Haslingden "Centre" Youth Provision (2012-14). The recent improvements to Greenfield gardens included the installation of a kick about area aimed at teenage users. There is little scope for further development of the site in relation to play.
- Water play area. The park has been updated this year.
- Knowsley crescent Play area. This park had new equipment, surfacing and fencing in 2008.
- Maden recreation ground (2018 2019). This park had new equipment and surfacing in 2008

It is also felt that other projects are not required within the timescale set. These are:

- Edenfield Play Area update (2-10-11). This play area is in good condition with a good range of equipment.
- Adelaide Street Removal (2011-12). There is no play area here!
- Loveclough Park (2012-14). The park is in good condition and there is no room for further equipment.

Remaining projects either need to be brought in to the three year plan or left as stated in the original tables.

This means that there is scope to move projects about in relation to the timescale of completion. Projects priority should also be reconsidered in light of the recent audit of our playground RoSPA report, in which a number of sites have high and medium risk items or a particularly excessive number of low risk items which can not be remedied unless new equipment is purchased.

These sites are:

Sites with at least one high priority item

Sharneyford Play area, Bacup

Sites with at least one medium priority item

Lumb Play Area, Water (note sign requirement is high but is a low cost "quick fix" and will be included in other works – not play strategy item)

Rising bridge Play Area, Haslingden.

Hill Street, Crawshawbooth

Mullards Play Area, Waterfoot.

Helmshore Play Area, Helmshore.

Victoria Park, Helmshore

Clegg Street, Haslingden

Worsley Park, Haslingden

Sites with low priority item(s) only

Station Road Play area, Healey

Edgeside Park, Edgeside (note any medium or high priority work associated with this site does not directly involve the play equipment and so can be done independently of any site development)

Moorlands Park, Bacup

I recommend, after consideration of all the above information that the three year action plan is as shown below subject to funding.
