- 5.1 There were a number of joint operations conducted with the Police, Trading Standards and VOSA during this period to address under age sales of alcohol and taxi enforcement.
- 5.2 The results of taxi enforcement checks have been mixed. Generally, vehicles were found to be clean and tidy with the drivers licensed and wearing their identification badges. However, on one occasion when 7 vehicles were inspected by VOSA, 6 of them were given immediate prohibitions for mechanical defects, mainly concerning tyres and lights.
- 5.3 A Tasking and Coordinating Group has been implemented with the Police to formalise and document the identification and action taken against licensed premises which are not being run properly.
