- 5.1 In June 2011 the Overview and Scrutiny Committee agreed its work programme for 2011/12. As part of that, it was agreed that a Task and Finish Group be established to look at the domestic violence services provided in Rossendale.
- The Task and Finish Group visited the STAR Centre which provides support to people suffering domestic abuse. They also visited the East Lancashire Women's Refuge Association which provides a safe environment for women and their children within East Lancashire.
- 5.3 Presentations were received from Victim Support, East Lancashire Drug and Alcohol Team, Green Vale Homes and the Police.
- 5.4 The Task and Finish Group also received statistical information from Lancashire County Council's Community Safety and Justice Co-ordinator.
