10. CONCLUSION

10.1 The rationale behind a licensing regime is to provide a service to the public that is accessible and safe and seen to be so. In issuing licences in respect of hackney carriages and private hire vehicles public safety is paramount and the regime is intended to prevent direct danger to the passenger from the driver of the vehicle and, perhaps slightly less danger to the passengers from the vehicle itself or the manner in which it is driven. Convictions, whether motoring offences or offences of dishonesty, assault, drug misuse or the like, bring into question whether a driver is 'a fit and proper person' to be transporting the public. In that respect those that are not fit should swiftly have their licences revoked and to extend the licence period to 3 years without checks on their convictions would pose a substantial increase in risk to the public. The significant reduction in the workload of the Licensing and Enforcement Unit and the reduction in licence fees that would result in a move to three year licences does not outweigh this.
