## 5. BACKGROUND AND OPTIONS

#### 5.1 **Other Licensing:**

There were no new licences granted during this period however the Licence at the Ashworth Arms, Burnley Road, Rawtenstall was surrendered.

- 5.2 In addition there were six changes of DPS at licenced premises
- 5.3 There were a number of complaints about six licensed premises in the Haslingden and Rawtenstall area over the period, all centred on noise nuisance and all the premises have been visited by police and licensing officers on a number of occasions.

#### 5.6 Exercises:

The following exercises were conducted during this period;

#### Test Purchasing

On 11<sup>th</sup> May 2012 a test purchasing operation at "on" licensed premises in the Rawtenstall and Haslingden areas took place. 7 premises were visited by police and enforcement officers. One "on" licensed premises failed, as a member of staff served the children alcohol. The offender received a police caution. All the other premises either refused to serve the children or asked for proof of age.

On 15<sup>th</sup> June 2012 the Police and Licensing Enforcement Officers visited 5 "on" licensed premises to check on the compliance with Licence conditions. One of the premises was found to be selling alcohol without a valid DPS for the premises and the premises were required to cease the sale of alcohol immediately. All other premises were in order.

### 5.7 Taxi Licensing.

At the time of writing this report there are 257 hackney carriage vehicles and 5 private hire vehicles.

There are 449 hackney carriage drivers and 7 private hire drivers licensed with this Authority.

#### Complaints:

There have been a total of 23 complaints regarding taxis plus a further 6 that did not return the licence plates on expiry of the licence as follows:

- 1 complaint of a noisy vehicle.
- 1 complaint of an abusive driver.
- 2 complaints of drivers receiving penalty points that they had not declared them.
- 6 complaints of vehicles with incorrect signage.
- 2 complaints of unreported damage to vehicles.
- 1 complaint of a vehicle sounding its horn next to a horse.
- 1 complaint of taxis dispensing thick black smoke.
- 1 driver who had failed to notify change of address.
- 1 complaint of a driver speeding.
- 1 complaint about the manner of driving.
- 4 complaints about unlicenced vehicles being used.
- 1 complaint about a driver refusing to collect a passenger.
- 1 complaint about a discrepancy in driving

#### **Exercises:**

The following exercises were conducted during this period

#### **Operation Spartacus**

This is a joint exercise with the police and licensing officers whereby taxis are stopped and road side checks are carried out.

<u>26<sup>th</sup> April 2012</u>: – one licensing officer and one police officer undertook the check between 10am and 12 noon, 5 vehicles were stopped and all were in order.

<u>27<sup>th</sup> April 2012</u>: – one licensing officer and one police officer undertook the check between 6pm and 8pm, 5 licensed vehicles were stopped and all were in order.

#### **Operation Green Flag**

On 10<sup>th</sup> May 2012 licensing Enforcement Officers carried out an operation to recover Taxi Plates from vehicles which had been suspended but failed to return the Taxi Licence plates. Two sets of suspended plates were obtained.

#### **Operation Maestro**

On the 18<sup>th</sup> May 2012 Officers from the Police, Licensing Enforcement Unit and VOSA (Vehicle and Operator Services Agency) carried out an operation to check the safety of licenced vehicles. 9 vehicles were stopped and 7 were checked by the VOSA officer. 2 of the vehicles were given an immediate prohibition and 1 was given a suspended prohibition. 2
