	January 2016.

# 2. PURPOSE OF REPORT

2.1 To request the Committee confirm the amendments to the Statement of Principles required under the Gambling Act 2005 and made in accordance with section 349 of the Act.

#### 3. CORPORATE PRIORITIES

- 3.1 The matters discussed in this report impact directly on the following corporate priorities:
  - A clean and green Rossendale creating a better environment for all.
  - A healthy and successful Rossendale supporting vibrant communities and a strong economy.
  - **Responsive and value for money local services** responding to and meeting the different needs of customers and improving the cost effectiveness of services.

#### 4. RISK ASSESSMENT IMPLICATIONS

4.1 There is a risk of non compliance with the requirements under Section 349 of the Gambling Act 2005 if the Statement of principles is not approved.

#### 5. BACKGROUND AND OPTIONS

- 5.1 Section 349 of the Gambling Act 2005 requires that the licensing authority prepare and publish a three year licensing statement of principles.
- 5.2 The current statement of principles expires 30<sup>th</sup> January 2013.
- 5.3 A revised Statement of Principles for the period 31<sup>st</sup> January 2013 to 30<sup>th</sup> January 2016 is appended at <u>Appendix A</u>.
- 5.4 A summary of the proposed changes to the Statement of Principles for the period 31<sup>st</sup> January 2013 to 30<sup>th</sup> January 2016 is as follows:
  - New population details from the 2011 Census.

- Change of name from Rossendale Borough Council Licensing Unit to Rossendale Borough Council Licensing and Enforcement Unit
- Clarification of where information registers, Licensed Operators and individuals who hold a personal licence are kept and available for public inspection.
- Change of Government department from Better Regulation Executive to department for Business, Innovation and Skills
- Clarification of Licence holder's responsibility at premises with gaming machines.
- Change of delegation when fee setting from officers to Licensing Sub Committee.
- 5.5 It is in the Councils Interest to approve the Statement of Principles under the Gambling Act as it is a statutory requirement under section 349 of the Gambling Act 2005. This will provide clarity to licensing customers on the principles to be applied by the Councils Licensing and Enforcement Unit.
- 5.6 The revised Statement of Principles must be published on or before the 3<sup>rd</sup> January 2013 in order to take effect on the 31<sup>st</sup> January 2013.
