2. PURPOSE OF REPORT

2.1 To update Members on the progress of the discussion to explore options for the management and operation of Rossendale Museum.

3. CORPORATE PRIORITIES

- 3.1 The matters discussed in this report impact directly on the following corporate priorities:
 - A clean and green Rossendale creating a better environment for all.
 - A healthy and successful Rossendale supporting vibrant communities and a strong economy.
 - Responsive and value for money local services responding to and meeting the different needs of customers and improving the cost effectiveness of services.

4. RISK ASSESSMENT IMPLICATIONS

4.1 There are no specific risk issues for members to consider arising from this report.

5. BACKGROUND AND OPTIONS

- 5.1 In June 2012 Cabinet approved a process to begin work to consider the current management arrangements for Rossendale Museum and to develop options for potential cost savings.
- Whitaker Park Museum currently opens to the public for 17.5 hours per week Tues-Thurs, Sat, Sun 1300-1630 and is managed by Lancashire County Council's Museum Service and is budgeted at an annual cost of £106,930.
- Officers have met with both officers from Lancashire County Council who provide the services on behalf of Rossendale Borough Council and members of the Friends of Whitaker Park Museum to begin discussions about potential areas for cost savings, how the future options may be developed, who would be included in the consultation stages and how the consultation would be undertaken.

5.4 Consultation has been carried out with Rossendale's Citizens Panel which asked the following questions:

Currently, Rossendale Museum, at Whitaker Park in Rawtenstall, is open 17.5 hours, over 5 days per week (Tuesday, Wednesday, Thursday, Saturday and Sunday) throughout the year.

Q: Have you ever visited Rossendale Museum?

3.9% Yes, more than once a month

19.0% Yes, more than once a year

10.6% Yes, once a year

8.3% Yes, less than once a year

31.9% Yes, once in the last few years

26.4% No, I have never visited Rossendale Museum

Q: If you have visited the Museum, what was the nature of your visit?

87.8% Personal visit out of interest

7.9% Visit as part of an organised group

14.2% Visit for an organised event

The Museum is managed by Lancashire County Council (LCC) but Rossendale Council pays for the service. LCC have confirmed that in order to reduce costs, they would need to reduce the opening times of the Museum. We think that we can save between £10,000 and £50,000 by doing this.

Q: Do you agree or disagree that we should consider options for reducing the opening times of the Museum in order to save money?

59.9% Agree

28.6% Disagree

11.5% Don't know

Q: We are also considering the option of inviting any other interested parties to run the Museum, at their expense. Do you agree or disagree that we should consider this option?

71.6% Agree

17.1% Disagree

11.3% Don't know

- 5.5 Formal notice has been served upon Lancashire County Council as the current managers and operators of the Museum to end the Management Agreement with effect from 31st March 2013. This is in accordance with the requirements of the Management Agreement which stipulated that minimum of 6 months notice should be given ending on the 31st March in any one year.
- 5.6 Serving notice allows both parties to enter into formal negotiations relating to the Management Agreement to explore the options to reduce the costs of the contract. It also may allow for the notice period to be extended but this will be subject to formal negotiations with Lancashire County Council. At this moment it is understood that Lancashire County Council would expect any extension of the notice to be for a period of not less than 12 months. Lancashire County Council have also indicated that they consider that TUPE would apply to posts associated with the staffing of the museum.

- 5.7 In order to ensure that all options are considered, the Council will be issuing a notice seeking expressions of interest from organisations who may wish to submit proposals to manage and operate the museum.
- 5.8 It is anticipated that expressions will be received by the end of January 2013.
