- 5.1 There was one new licences granted during this period. (Peony Chinese Restaurant).

# 5.6 Exercises:

The following exercises were conducted during this period;

# Test Purchasing

On 16<sup>th</sup> August 2012 a test purchasing operation at "off" licensed premises in the Rawtenstall and Haslingden areas took place. 8 off licence premises were visited by police and enforcement officers. One off licence failed, as the husband of the premises licence holder served the children alcohol. The offender elected to undertake a course in responsible alcohol retailing in lieu of prosecution. All the other premises either refused to serve the purchasers or asked for proof of age.

# 6. Taxi Licensing

- 6.1 At the time of writing this report, Rossendale Borough Council there are:
  - 333 hackney carriages
  - 526 hackney carriage drivers
  - 6 private hire vehicles
  - 8 private hire drivers, and
  - 4 private hire operators

#### 6.2 Exercises:

The following exercises were conducted during this period

#### **Operation Maestro**

Operation Maestro, a taxi enforcement exercise, was deployed by the Council's Licensing and Enforcement Unit, Lancashire Police and VOSA (Vehicle and Operator Services Agency) and shadowed by 3 councillors during the evening of Friday 10<sup>th</sup> August 2012 in the Rawtenstall area of the valley.

During the evening, 8 licensed hackney carriages were stopped and inspected with 4 of those being selected for an inspection at one of the Council's designated garages by a VOSA inspector of which all 4 vehicles were issued with a suspended or delayed prohibition notice for faults such as tyres below the legal limit, a missing wheel nut, defective brake lights, split CV gaiters, leaking brake callipers.

In addition to the VOSA checks, council officers found 3 defective roof signs, a defective meter, filthy and torn passenger seats, filthy passenger windows and the absence of no smoking stickers resulting in the issue of 2 Council suspension notices and 2 defect notices.

#### Oldham Exercise

On the 6<sup>th</sup> September, 2012, two enforcement officers, together with Oldham Licensing officers and Greater Manchester Police, conducted a taxi exercise in Oldham, where taxis were stopped and taken for examination to the Oldham Council MOT station. Four of the vehicles were licensed at Rossendale as hackney carriage vehicles and being used in Oldham for private hire purposes. All four were found to have the meter set at incorrect tariffs and were suspended. Further similar exercises are planned.

#### Taxi driver appeals

On 26<sup>th</sup> June, Mahmood Hussain had his application determined by Rossendale Council's Licensing Committee. After hearing Hussain had a conviction in 2007 for possession with intent to supply cannabis and two driving convictions for exceeding the speed limit on a motorway in 2008 and using a mobile phone while driving a motor vehicle in 2010, the Committee considered that Hussain was not a fit and proper person to hold a taxi licence. The appeal was heard by Reedley magistrates on 26<sup>th</sup> September and the decision of the Council was upheld.

6.3 No drivers have been suspended during this period.
