### Response to other points raised at O&S meeting on 19<sup>th</sup> November 2012 not covered in the covering report.

- How large is the tank at Henrietta Street?
  - o 10,000 litres. No budget to install a larger one and not sure if there is any cost benefit.
- What was the most economic speed of the wagons?
  - Most vehicles are at their peak around 56mph not aware of any specific speed for this type of vehicle but majority of time spent around 5 mph driving from one house to another.
- Were the bin wagons taking 100% of wastage in their wagons?
  - o Yes, unless it is the last load which will weigh whatever is left.
- Could the Council not change from road vehicle to plant vehicles?
  - o No. There is no plant type vehicle built that can lift wheeled bins and the range of vehicles that can run on 'red' diesel has been dramatically reduced.
- Do the Council use agency cards?
  - Yes Communities. However, fuel is more expensive through this method and Communities only do so when working at far side of the valley (away from our depot)
