#### **1. OVERVIEW**

#### The main aims/objectives of this policy<sup>1</sup> are: As part of the on-going financial cuts the Council must undertake, this policy decision proposes changes to the Refuse, Recycling and Street Cleansing Service as follows: Re-profile the Town Centre Caretaker service to generate savings of c£39,100; • Renegotiate funding dedicated to the Whitworth Town Centre Caretaker Service. in accordance with the Whitworth Town Council wishes; Market Caretaker post to become full-time at a cost of c£5,000. This is reflective • of the reduction in the TCC service and to allow the Market Caretaker to take on full responsibility for opening and closing all markets; Remove recycling 'bring sites' across the borough, and bring forward revised policies for the collection of garden waste, and missed bins. Collectively this will generate savings of c£66,500; Remove one cage truck and one post – generating a saving of c£30,500; • Remove one pavement sweeper and one post to generate savings of c£34,000: Stand down one road sweeper to be used as a spare and remove one post to generate savings of c£64,000; Remove one supervisor post from the establishment to generate savings of • c£30,000.


