# 5.6 Taxi Licensing.

- At the time of writing this report, licensed at this Authority there are:
  - 910 hackney carriage vehicles
  - 1471 hackney carriage drivers
  - 4 private hire vehicles
  - 9 private hire drivers
  - 4 private hire operators
- Between the 1<sup>st</sup> April and the 31<sup>st</sup> December 2013 we licensed 733 <u>new</u> drivers and 418 <u>new</u> vehicles.
- Currently the Authority is averaging 20 new drivers and 15 new vehicles each week.
- During this period, 84 applicants for hackney carriage driving licence appeared before the sub-committee to have their application determined. The sub –committee:
  - o refused 67 applicants
  - 3 licences were revoked
  - 1 not renewed, and
  - $\circ$  the remainder of the applications were granted.
- 14 of the above applicants subsequently appealed to the Magistrate's Court against the decision to refuse their application. The Court refused 9 of the appeals and granted 5 of them. Costs were awarded against the applicant in 7 of the cases.

## Complaints:

There have been a total of 49 complaints regarding taxis as follows:

- 7 regarding the manner of driving
- 4 regarding unreported road traffic damage
- 2 regarding absence of plates
- 2 regarding overcharging
- 1 regarding smoking
- 7 regarding defects on vehicles
- 5 regarding undeclared points on DVLA licence
- 5 regarding signage
- 12 regarding conduct
- 4 regarding insurance.

#### Exercises:

- Joint working operations were carried out with the Police and VOSA on the 28<sup>th</sup> June, 13<sup>th</sup> September and 6<sup>th</sup> December 2013. A total of 25 vehicles were stopped and inspected. Of those:
  - 6 were suspended from use by VOSA
  - o 6 were found to have minor defects and were issued with defect notices
  - 1 driver was found not to be licensed
  - 2 drivers had no badge with them.
- Defects ranged from steering and suspension, tyres, lights, air bag faults to bodywork damage, broken mirrors and dirty vehicles.
- A joint check was carried out in Burnley with Burnley Council's Licensing team and Lancashire Constabulary on the 17<sup>th</sup> May 2013. No Rossendale licensed vehicles were found.
- Also on the 17<sup>th</sup> May in the company of engineers from Lancashire County Council, a check was carried out on taxis under contract to LCC at Cribden House School. No vehicles licensed with Rossendale were found to be defective.
