1.	RECOMMENDATION(S)
1.1	That the Corporate Scrutiny Committee resolves to recommend to Council the adoption of the
	revised Statement of Licensing Policy relating to the Licensing Act 2003 for a further five
	years.

2. PURPOSE OF REPORT

2.1 To request the Committee confirm the amendments to the Statement of Licensing Policy required under the Licensing Act 2003 and made in accordance with section 5 of the Act.

3. CORPORATE PRIORITIES

- 3.1 The matters discussed in this report impact directly on the following corporate priorities:
 - Regenerating Rossendale: This priority focuses on regeneration in its broadest sense, so it means supporting communities that get on well together, attracting sustainable investment, promoting Rossendale, as well as working as an enabler to promote the physical regeneration of Rossendale.
 - Responsive Value for Money Services: This priority is about the Council working collaboratively, being a provider, procurer and a commissioner of services that are efficient and that meet the needs of local people.
 - Clean Green Rossendale: This priority focuses on clean streets and town centres and well managed open spaces, whilst recognising that the Council has to work with communities and as a partner to deliver this ambition

4. RISK ASSESSMENT IMPLICATIONS

- 4.1 All the issues raised and the recommendation(s) in this report involve risk considerations as set out below:
 - There is a risk of non compliance with the requirements under Section 5 of the Licensing Act 2003 if the Statement of Licensing Policy is not approved.

5. BACKGROUND AND OPTIONS

- 5.1 Section 5 of the Licensing Act 2003 requires that the licensing authority prepare and publish a statement of licensing policy at least every five years.
- 5.2 The current statement of Licensing Policy has stood the test of time and the amendments that have been found to be necessary are relatively minor and as a result of changes in legislation and practical experience.
- 5.3 A revised Statement of Licensing Policy for a further five years commencing when full Council

approval has been received is appended at Appendix A.

- 5.4 A summary of the proposed changes to the Statement of Licensing Policy is as follows:
 - New Rossendale statistic details from the 2011 Census.
 - Change of name of Office Manager to Licensing and Enforcement Unit Manager.
 - Addition of new legislation, Live Music Act 2012 and the Police and Social Responsibility Act 2011.
 - Clarification of Live Music Act 2012 exemptions at section 5.2.
 - Removal of the words, 'in particular live music and dancing' at paragraph 5.17.
 - Addition of paragraph 20.2 in relation to an application for a Late Temporary Event Notice.
 - Increase of the hours a Temporary Event Notice can be in existence.
 - Confirmation that the Sexual Entertainments Venues policy has now been adopted.
 - Removal of the vicinity test.
