In response to this application.

Police have visited The Station Hotel in Helmshore on a number of occasions over the past year and below are brief details of police visits and interventions in that time. As you can see the vast majority of reported incidents refer to complaints regarding noise at the premises and in particular in relation to the beer garden. Police visits to the premises have not revealed any other issues or concerns. Police have no concerns in relation to crime & disorder at the premises.

17/07/2013 – DPS Nicola Barcroft spoken to regarding concerns about the bands playing on the car park. DPS stated she fully understands police concerns and will make sure she abides by her licensing conditions and monitors noise.

17/08/2013 – Incident LC-20130817-1772 refers to a noise complaint at 23:09.

06/09/2013 - Police visit at 23:40. Very quiet and premises about to close.

07/09/2013 – Incident LC-20130907-1589 is noise complaint regarding a live band at the premises.

27/09/2013 - Police visit at 23:45. 25 to 30 people present and all good natured and no excessive noise issues.

29/09/2013 - Police visit at 00:50. Well behaved customers and a merry atmosphere.

12/10/2013 – Police visit and customers seen outside with glasses and advice given.

03/11/2013 - Police visit at 01:25. DPS appeared to be under the influence of alcohol.

08/11/2013 - Police visit at 23:50. No issues or concerns.

07/12/2013 - Police visit at 01:00. No issues or concerns. About 20 persons present.

16/12/2013 – Crime reference FL1302005 refers to an allegation that someone had been assaulted on the pub car park at 04:30am.

02/01/2014 – Police visit at 00:35 and a number of people were found at the front of the premises with drinks.

18/01/2014 - Police visit at 00:30. No issues or concerns.

02/02/2014 – Police visit at 01:20. Low numbers inside but all in good spirits. Jukebox being played but at a low level.

15/03/2014 - Police visit at 00:30. Noise/music at an acceptable level and not excessive.

18/04/2014 - Incident LC-20140418-1658 refers to a report of an intoxicated male outside the pub refusing to leave.

25/05/2014 – Incident LC-20140525-1532 refers to a report at 22:49 that the beer garden at the premises was still open and this was a breach of the licence. People were being loud and swearing. Premises checked within the hour by police and reported no issues.

14/06/2014 – Incident LC-20140614-1452 refers to a group of football fans in the beer garden of the premises at 20:00 and they appeared drunk were shouting and swearing and some were urinating in the corner of the car park. Further call at 22:01 stating the language was appalling and children shouldn't have to hear this. This was the evening of one of Englands World Cup matches.

28/06/2014 - Police visit at 00:29. Relaxed pleasant atmosphere and no loud music.

29/06/2014 – Police visit at 00:30. No issues or concerns.

03/07/2014 – Incident LC-20140703-1601 refers to a complaint at 23:18 that a lot of noise is coming from the pub.

12/07/2014 - Incident LC-20140712-1679 refers to a noise nuisance complaint regarding bad language by people in the beer garden.
