1.1 This report presents the 2nd Draft Statement of Community Involvement (SCI) to be issued for a second round of Full public consultation in accordance with the regulatory requirements of the Planning and Compulsory Purchase Act 2004.

2. **RECOMMENDATIONS**

2.1 That Cabinet recommends that Full Council endorses the Statement of Community Involvement (SCI) in order for it to be published for consultation.

3. REPORT AND REASONS FOR RECOMMENDATIONS AND TIMETABLE FOR IMPLEMENTATION

- 3.1 The SCI forms part of the Local Development Framework (LDF) and sets out Rossendale Borough Council's policy for involving the stakeholders in the development of the LDF. The SCI sets the Council's policy for involving the local community and statutory consultees in the preparation and revision of the LDF and consultation on planning applications.
- 3.2 The SCI has been revised following Full public consultation on the 1st Draft SCI during August October 2005. Details on the consultation exercise, the representations received and how they have contributed to the revised 2nd Draft can be viewed in the Statement of Consultation attached with the SCI and this report.
- 3.3 Following the initial consultation the SCI has been revised and now requires a further period of consultation for a minimum of 6 weeks. This is due to a section on Pre application consultation being prepared in section 3 of the document. This section has been prepared following a review of the Council's

Development Control service. The approach developed is based on the outcomes of this review and includes:

- The Council's Practice for Publicising Planning Applications
- The approach to Pre-application Discussions
- Development Control's approach to Community Consultation
- Details on Consultation Statements
- 3.4 Once comments are received on the 2nd Draft SCI, Rossendale Borough Council will revise the document subject to representations being made. The document is then submitted to the Government and will be issued for further period of consultation for a minimum of 6 weeks and go through an independent examination that will be led by a Government-appointed Inspector.
