The Licensing Enforcement Officer presented the report detailing the circumstances which had brought the Driver before the Sub-Committee.

The Driver and his solicitor presented his case to the Sub-Committee.

The Sub-Committee Members asked questions of the Driver and the Licensing Enforcement Officer for clarification purposes only.

The Driver, his solicitor and the Licensing Enforcement Officer left the room to enable the Sub-Committee to determine the application.

Resolved:

- 1. That the licence is revoked with immediate effect. The Sub-Committee did not consider Mr HNA a fit and proper person to hold a hackney carriage drivers licence.
- 2. The driver was informed of his right of appeal to the magistrates court which must be exercised within 21 days of service of the decision letter upon him.
- 3. The driver was informed of the reason for the decision and that he would receive written confirmation of the Council's decision.
