**Resolved:**

1. That the licence be revoked under s.61 of the Local Government (Miscellaneous Provisions) Act 1976. The Committee consider that the applicant is no longer a fit and proper person to hold a Hackney Carriage Driver's Licence.
2. That Mr SS was notified of his right of appeal to the magistrate's court which must be exercised within 21 days of service of the decision letter upon them.
3. That Mr SS was served with the decision letter before he left the room.
