### **BUSINESS MATTERS**

# 1. APOLOGIES FOR ABSENCE

There were no apologies for absence from the Sub-Committee; all members were present.

# 2. DECLARATIONS OF INTEREST

Councillor De Souza declared an interest in Item C4, as the issues had occurred within her ward. Councillor Smallridge was proposed and seconded to chair Item C4.

### 5. REPORT TO CONSIDER AN EXISTING HACKNEY CARRIAGE DRIVERS LICENCE – MR JAA (Item C2)

The Chair welcomed the Driver to the Sub-Committee.

The Licensing and Enforcement Manager presented the report detailing the circumstances which had brought the Driver before the Sub-Committee.

The Driver presented his case to the Sub-Committee.

The Sub-Committee Members asked questions of the Driver and the Licensing and Enforcement Manager for clarification purposes only.

The Driver and the Licensing officers left the room to enable the Sub-Committee to determine the application.

#### **Resolved:**

- 1. That the hackney carriage drivers licence is suspended for a period of one month.
- 2. The driver has a right of appeal to the magistrates court which must be exercised within 21 days of service of the decision letter upon him. The suspension would therefore take effect after the 21 day appeal period.
- 3. Should the driver choose to appeal the decision then he may continue to operate as usual until the date of the appeal hearing. If the magistrates court were to uphold the decision then the suspension will take place effect following this determination.
- 4. The driver must surrender their badge to the Licensing Unit by midday on the first day of the suspension period.
- 5. The driver's badge will be returned at the end of the suspension period.
- 6. The driver was served with the decision letter before he left the room.

- 3. Mr QH was served with the decision letter before he left the room.

The report had been considered in accordance with the Council's approved procedure, the Council's Guidelines on Convictions, Byelaws relating to Hackney Carriages, and the Sub-Committee took into account all the relevant information put before them.
