# 5. REPORT TO CONSIDER AN EXISTING HACKNEY CARRIAGE DRIVER – MR MA (Item C2)

The Chair welcomed the Driver and his brother to the Sub-Committee.

The Licensing Enforcement Officer presented the report and detailed the circumstances which had brought the Driver before the Sub-Committee.

The Driver and his brother presented the case to the Sub-Committee.

The Sub-Committee Members asked questions of the Driver and the Licensing Enforcement Officer for clarification purposes only.

The Driver, his brother and the Licensing Enforcement Officer left the room to enable the Sub-Committee to come to a decision.

#### Resolved:

- 1. That the Licensee be required to take and pass the DVSA test and have provided evidence of this to the Licensing and Enforcement Unit within a period of 3 months (or evidence be provided that an appointment could not be obtained). If evidence was not provided within 3 months then the driver would be called back to the Sub-Committee.
- 2. The Driver was informed of his right of appeal to the Magistrates' Court which must be exercised within 21 days of receipt of notification of the decision.
- 3. The driver was informed of the reasons for the decision and that he would receive written notification of the decision.

#### Reason for Decision

The matter had been considered in accordance with the Council's approved procedure, the Council's Guidelines on Convictions, Byelaws relating to Hackney Carriages, and the Sub-Committee took into account all the relevant information put before them.

# 6. REPORT TO CONSIDER AN EXISTING HACKNEY CARRIAGE DRIVER - MR FEF (Item C3)

The Chair welcomed the Driver and his two representatives to the Sub-Committee.

The Licensing Enforcement Officer presented the report and detailed the circumstances which had brought the Driver before the Sub-Committee

The Driver and his representatives presented the case to the Sub-Committee.

The Sub-Committee Members asked questions of the Driver, his representatives and the Licensing Enforcement Officer for clarification purposes only.

The Driver, his representatives and the Licensing Enforcement Officer left the room to enable the Sub-Committee to come to a decision.

#### Resolved:

- 1. That the driver's Hackney Carriage licence be suspended for a period of 28 calendar days.
- 2. The driver was informed of his right of appeal to the Magistrates' Court which must be exercised within 21 days of receipt of notification of the decision.
- 3. The driver was advised that should he choose to appeal the decision then he could continue to operate as usual until the date of the appeal hearing. Should the court refuse the appeal, the suspension would take effect following this determination.
- 4. He was advised that he must surrender his badge to the Licensing Unit by midday on the first day of the suspension period.
- 5. The badge would be returned to the driver at the end of the suspension period.

6. The driver was informed of the reasons for the decision and that he would receive written notification of the decision.

#### **Reason for Decision**

The matter had been considered in accordance with the Council's approved procedure, the Council's Guidelines on Convictions, Byelaws relating to Hackney Carriages, and the Sub-Committee took into account all the relevant information put before them.

# 7. REPORT TO CONSIDER AN APPLICATION FOR A HACKNEY CARRIAGE DRIVERS LICENCE - MR UKK (Item C5)

- 3. The Applicant was informed of the reason for the decision and that he would receive written confirmation of the council's decision.
