1.	RECOMMENDATION(S)
1.1	Members are recommended to approve the write off of:-
	£106,509.54 in respect of irrecoverable Non-Domestic Rate debt.
	£25,060.78 in respect of irrecoverable Council Tax debt
	£25,889.63 in respect of irrecoverable Housing Benefit overpayment debt
	£13,812.64 in respect of Sundry Invoice debts

2. PURPOSE OF REPORT

2.1 The purpose of the report is to request member authority to write off bad debts of Non-Domestic Rates which are above the delegated limit of £5000 (see appendix)

3. CORPORATE PRIORITIES

- 3.1 The matters discussed in this report impact directly on the following corporate priorities:
 - Responsive Value for Money Services: This priority is about the Council working collaboratively, being a provider, procurer and a commissioner of services that are efficient and that meet the needs of local people.

4. RISK ASSESSMENT IMPLICATIONS

4.1 There are no specific risk issues for members to consider arising from this report.

5. BACKGROUND AND OPTIONS

- 5.1 It is prudent practice to clear any debts from the ledgers which are now deemed to be irrecoverable.
- The sum of £106,509.54 is regarded as irrecoverable in respect of NNDR; In the majority of cases this is because the companies in question have liquidated. In one case it has been necessary to re-bill and re-commence recovery action for unpaid rates. However the earliest years of liability are now statute barred.
- 5.3 The sum of £25,060.78 is regarded as irrecoverable in respect of Council Tax. In these cases the indebted parties are variously deceased, absconded abroad or bankrupt.

- 5.4 The sum of £42,748.55 is regarded as irrecoverable in respect of Housing benefit overpayments. In these cases all possible recovery action has been exhausted.
- 5.5 The sum of £13,812.64 is regarded as irrecoverable in respect of property rentals. In both cases the companies involved have ceased trading and all possible recovery action has been exhausted.
- 5.6 A record of all debts written off is maintained in the event that there is an opportunity for future collections
