2.1 To provide the Committee with an update on implementation and progress of previously adopted taxi licensing policy

- 5.1 On 15<sup>th</sup> November 2016 Licensing Committee agreed and adopted a set of conditions applicable to drivers and vehicles licensed by the authority as either hackney carriage of private hire.
- 5.2 A number of these conditions included practical changes to both vehicles and drivers, and introduced changes to vehicle specification and requirements, as well as stricter testing requirements for new and existing drivers.
