We are carrying out our duties efficiently and proactively and making this representation as we have concerns about the likely impact of the proposed activities on the licensing objectives. We are focusing on the impact on people living in the vicinity of the premises.

Environmental Health have concerns about the possibility and potential of public noise nuisance arising from the use of the premises and do not feel that the steps the applicants intend to take, as detailed on the premises application (dated 15 September 2017) to promote the prevention of public nuisance are sufficient. We feel that live music and the late opening hours are excessive on frequency and duration. We feel the possible impacts could be disproportionate and unreasonable. We feel the proposals are inadequate to the extent that widespread nuisance might result. When a recent planning application was submitted it was for change of use from public house to restaurant. The 02.00hrs opening for a restaurant on Friday to Sunday seems excessive.

The Swan Hotel is located outside the town centre (see the map on photo 1 the town centre is highlighted in green). As well as being located outside the town centre it has a residential building adjacent to the front elevation at 98 Market Street Bacup (see photo 2) and the side elevation shares a party wall with 2 Rockcliffe Road (see photo 3) which is another residential property. 2 Rockcliffe Road is a private rented property and 98 Market Street is a long term empty property and 96 Market Street is a recently vacated private rented property. We have concerns that the owners of these properties may not know about the licence application and therefore not put in objections and going forward if and when new tenants or occupiers move in they would experience unreasonable disturbance.

Risk factors and the suggested control measures are as follows:

Limit live music, recorded music, late night refreshment, sale of alcohol and opening hours on Fridays and Saturdays 12 noon to midnight and on Sundays to Thursdays 12 noon to 23.00hr.

Sound amplification systems and entertainment in general: The property is currently undergoing alterations and it's an ideal time to install air conditioning because doors and windows should be kept closed when live music is being played.

Ensure speakers are kept inside the property away from doors and windows and the party wall with 2 Rockcliffe Road and ensure that anti-vibrations mountings for speakers are used.

Handling of barrels, kegs, cylinders and bottles outside: Ensure applicant uses rubber matting and handling aids for the movement of barrels, cylinders, bottles etc.

Applicant not to remove waste and bottles after 22.00hrs

Customers both inside and outside the premises: Applicant to use signs to advise patrons and staff to be quiet when leaving the premises
