2. PURPOSE OF REPORT

- 2.1 To agree the Constitution for the 2018/19 Municipal Year.
- 2.2 The purpose of the Constitution is to:
 - a) Enable the Council to provide clear leadership to the community in partnership with citizens, businesses and other organisations.
 - b) Support the active involvement of citizens in the process of local authority decisionmaking.
 - c) Help members represent their constituents more effectively.
 - d) Enable decisions to be taken efficiently, effectively and transparently, with due regard to probity and equity.
 - e) Create a powerful and effective means of holding decision makers to public account.
 - f) To ensure that no one will review or scrutinise a decision in which they were directly involved.
 - g) Ensure that those responsible for decision-making are clearly identifiable to local people and that they explain the reasons for decisions.
 - h) Provide a means of improving the delivery of services to the community.

 - A connected and successful Rossendale that welcomes sustainable growth: our
 priority is to ensure that we are well connected to our residents, key partners and
