PLANNING APPLICATIONS

The chair noted that the planning officers would be outlining the main points of the application and any relevant additional information. She noted that the committee were given copies of all reports and plans in advance of the meeting, which they had adequate time to read.

5. Application Number 2019/0098 (Agenda Item B1) Land off Hall Street, Whitworth Full: vehicular access (re-submission of refused application no. 2018/0514)

The Principal Planning Officer outlined the application as detailed in the report.

A vehicular access and roadway had been formed to the site from Hall Street but without the necessary planning permission. This application had therefore been submitted with a view to

obtaining both retrospective approval for the works that had been carried out to date and approval to complete them. The formation of a vehicular access onto an unclassified road such as this would not normally require formal planning permission. However, approval was required in this instance because of the extent of the engineering works involved.

The officer's recommendation was for approval subject to the conditions set out in section 10 of the report.

There were no speakers registered in favour or against the application.

Councillors Powell and Neal spoke against the application.

In determining the application members discussed the following:

• Effect on residents' water supply

Clarification was provided on the point raised.

6. Application Number 2018/0577 (Agenda Item B2) Land rear of 410 – 420 Newchurch Road, Rawtenstall Erection of dwellinghouse

The Principal Planning Officer outlined the application as detailed in the report.

Permission was sought to erect on the site a detached 7-bedroomed dormer-bungalow, specifically designed at ground floor level to meet the requirements of two disabled children, and with an integral double-garage.

The officer's recommendation was for approval subject to the conditions set out in section 12 of the report.

Ms Harwood spoke against the application.

Mr Gee spoke in favour of the application.

Councillor Gill spoke in favour of the application.

In determining the application members discussed the following:

- The council's legal responsibility to find land for the applicant to purchase.
- The number of parking spaces for the property.

Clarification was provided on the points raised.
