Title : Rossendale Local Plan

Subject Matter and area covered by the Plan

Rossendale Borough Council has published the Local Plan that it intends to submit to the Minister for Housing, Communities and Local Government for independent examination.

The Local Plan will cover the whole of Rossendale borough and will provide the statutory planning framework for the borough up to 2034. The Plan will be used to guide decisions on planning applications and areas where investment should be prioritised. The Plan contains a vision, objectives and an overall strategy for development and policies on both the scale of development and its overall pattern across the borough. It will allocate many of the sites that are needed to accommodate new development and designate areas to be protected or enhanced. It also sets out policies on how planning applications on allocated and 'windfall' sites will be judged.

Period for Representations

The Rossendale Local Plan has been consulted on previously. This is your opportunity to make representations about the draft plan prior to it being submitted for independent examination. At this stage we are inviting views on the soundness, legal compliance, and compliance with the Duty to Cooperate. Any comments made will be forwarded on for consideration by the appointed Planning Inspector as part of the examination process.

Representations on this document can be made over a 6 week period starting Thursday 23rd August 2018, and must be received on or before **Friday 5th October 2018**.

Comments arriving after this time will not be accepted.

- Publication of the recommendations of the person appointed to carry out the independent examination of the Rossendale Local Plan
- Adoption of the Rossendale Local Plan

If you submit the online form you will be asked to confirm this.

Content and Structure of Your Representations

The Local Plan for Rossendale will be submitted early next year for examination by an independent Planning Inspector, appointed by the Secretary of State. The Inspector's role will be to assess that the Local Plan has been prepared in accordance with the Duty to Cooperate, the legal and procedural requirements and whether it is sound.

Further guidance on preparing a response to this consultation on the Local Plan can be found in guidance issued by the Planning Inspectorate, which is available to view at https://www.gov.uk/government/publications/examining-local-plans-procedural-practice

The Planning Inspector will consider representations made in relation to the legal tests that underpin the Examination. Any comments on the Local Plan should specify the matters to which they relate and the grounds on which they are made.

Only the following matters will be of concern to the independent Planning Inspector:

- Legal Compliance does the plan meet the legal requirements made under various statutes?
- **Soundness** has the plan been positively prepared, justified, effective, and consistent with national policy?
- **Meets Duty to Cooperate** has the Council engaged and worked effectively with neighbouring authorities and statutory bodies?
