Coronavirus – Business Grant Funding

The Government has announced the following grants for qualifying businesses:

Small Business Rate & Rural Rate relief recipients	£10,000
Retail, Leisure & Hospitality businesses (rateable value less than £15,000)	£10,000
Retail, Leisure & Hospitality businesses (rateable value £15,000-£51,000)	£25,000

This funding has been made available by the Government in order to support business in response to Coronavirus, Covid-19. The Government has made clear that it will not accept manipulation of records to claim grant monies and that any business caught falsifying records will face prosecution. Rossendale Borough Council may use the information provided or share it with other public bodies for the purposes of preventing and detecting fraud.

If any of the company or trader address details are different from the address on this letter, you should contact the business rates team order to confirm your registration/occupancy details.

The United Kingdom left the EU on 31 January 2020, nonetheless under the Withdrawal Agreement the State aid rules continue to apply during a transition period, subject to regulation by the EU Commission. Grant awards constitute State Aid and applications should be made in consideration of State aid rules.

Rossendale Borough Council must be satisfied that all state aid requirements have been fully met and complied with when making grant payments, including, where required: -

- compliance with all relevant conditions of the EU state aid and de-minimis regulation,
- The EU commission temporary framework for State Aid measures to support the economy in the current COVID-19 outbreak,
- the UK notified and approved scheme under that temporary framework and any relevant reporting arrangement to the EU commission.
