## **Details of Decision to be taken:**

To authorise the Director of Economic Development to enter into a 100% grant funding agreement with DWP to extend the Rossendale Youth Works project for a further 12 months.

Clear Reasons why it is impractical to defer the decision until it has been included in the next Forward Plan:

The current Rossendale Youth Works funding comes to an end on the 31st October 2021. The negotiations with the DWP for continuation funding have been delayed due to the DWP redesigning the application process and the changing of the required outputs and funding parameters. This has resulted in very tight timescales being imposed upon us. The project needs continuity for the existing applicants. At present the project will close down on 31st October unless a new contract is accepted from 1st November. Our partners have indicated that they can sustain a very small gap in order to provide continuity for the candidates but this is extremely limited and requires an urgent decision.
