- ✓ I understand any furniture I am permitted to place on the highway must be robust, easily cleaned and in good operational condition at all times.
- ✓ I understand that permission to place furniture on the Highway will be granted for an initial period of <u>up to</u> 12 months, to assist with the Covid-19 restrictions on business operations, and that should I be granted such permission it does not set any precedent for any future use of the highway after the expiry any this licence.
- ✓ I understand use of any licensed area, will be subject to 3 monthly safety and impact reviews.
- ✓ I understand that all applications for a licence to use the highway, will be considered on their own merit on a case by case basis and that the Councils decision is final, *There is no right of appeal*.
- ✓ I confirm that public liability insurance (minimum of 5 million) is in place covering the use of the proposed area, and I will enclose a copy with this application.
- ✓ I understand that this fee is non-refundable should my application be refused or should I have my licence revoked in the future.
- ✓ I agree that I will comply with all licence conditions attached to the pavement licence.
- ✓ I understand that a consent can be revoked at any time for the following reasons
  - A breach of licence condition has occurred
  - A public health or safety risk has been identified
  - The highway is being obstructed other than the permitted area
  - Anti-social behaviour or public nuisance is being caused
  - The applicant is found to have made a false or misleading statement on application or found not to have fully complied with the advertising process.
  - The designated area or any part of the area is deemed as no longer suitable for use.
- ✓ I understand that the Authority is under a duty to protect the public funds it administers, and to this end may use the information I have provided on this form for the prevention and detection of fraud. I understand that it may also share this information with other bodies responsible for

auditing or administering public funds for these purposes
