Contracts are to be exchanged within one month of acceptance of the tender. 10% of the purchase price is to be paid upon exchange of contracts. Should the successful bidder not complete the purchase of the land within three months of acceptance of their tender, the Council reserves the right to withdraw the offer of sale and offer the land to

the next highest bidder. The legal and

administrative costs need to be paid upon sale

completion.
